## AN ORDER PROVIDING FOR THE OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE POLICIES

WHEREAS, Section 2 of Proclamation No. 922, which was issued by the President of the Philippines declaring a state of public health emergency throughout the Philippines, mandated that all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

WHEREAS, in compliance with the National directive, the City of Mandaue was placed under a state of Enhanced Community Quarantine starting March 31, 2020 to prevent the spread of Covid-19 by limiting nonessential movement of person and transportation within the City;

WHEREAS, the Inter-Agency Task Force on on April 24, 2020, released guidelines on the gradual resumption of economic activity in areas under a general community quarantine (GCQ) and those under enhanced community quarantine (ECQ) which was deemed effective from May 1 to May 15, 2020, with the condition that minimum health standards are achieved and continually observed;

WHEREAS, on May 11, 2020 the Inter-Agency Task Force (IATF) on COVID-19 issued Resolution No. 35 classifying the City of Mandaue as a moderate-risk Highly Urbanized City (HUC) and placed Mandaue City under General Community Quarantine from May 16 until May 31, 2020. The classification was, thereafter, appealed by the City to the Regional IATF-MEID, which recommended a reclassification from moderate-risk to high-risk, and was eventually granted by the National IATF-MEID on May 15, 2020 eventually placing the City under Enhanced Community Quarantine, from May 16, 2020 until May 31, 2020 by virtue of IATF Resolution No. 37;

WHEREAS, together with Resolution No. 37, the IATF issued the Revised Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, which intends to harmonize and codify existing policies of the IATF applicable to all regions, provinces, cities, municipalites, and barangays placed under community quarantine.

WHEREAS, considering these recent issuances, there is a need to revise existing Mandaue City issued guidelines on community quarantine to streamline the national directives, thus, the City hereby adopts the Revised Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines set by the National IATF-MEID and declares its policies under this classification of community quarantine;

NOW THEREFORE, I, JONAS C. CORTES, Mayor of the City of Mandaue, and by virtue of the powers and authority vested in me by law, do hereby order and decree for the adoption of the guidelines under the Revised Omnibus Guidelines on the Implementation of Community Quarantine, which

maintained the City of Mandaue under the Enhanced Community Quarantine and Provide the Guidelines on the Resumption Allowed Business Establishments:

SECTION 1. DECLARATION OF ENHANCED COMMUNITY QURANTINE. Mandaue City shall remain to be under a state of Enhanced Community Quarantine (ECQ) until May 31, 2020.

**SECTION 2. DEFINITION OF TERMS.** In addition to definitions found in existing regulations in relation to Covid-19 pandemic, the following terms are defined for guidance:

 Agriculture - includes the yield of the soil, such as corn, rice wheat, rye, hay, coconuts, sugarcane, tobacco, root crops, vegetables, fruits, flowers, and their byproducts; ordinary salt; all kinds of fish; poultry; and livestock and animal products, whether in their original form or not.

The phrase "whether in their original form or not" refers to the transfers to the transformation of said products by the farmer, fisherman, producer or owner through the application of processes to preserve or otherwise to prepare said products for the market such as freezing, drying salting, smoking, or stripping for purposes of preserving or otherwise preparing said product s for market.

- Comorbidity refers to the presence of a pre-existing chronic disease condition
- Essential Goods and services covers health and social services to secure the safety and wellbeing of persons, such as but not limited to food, water, medicine, medical devices, public utilities, energy and others as may be determined by the Inter-Agency Task Force.
- 4. Food manufacturing includes every person who, i. by physical or chemical process, alters the exterior textures or form or inner substance of any raw material or manufactured food product in such manner as to prepare it for food to which is could not have been put in its original condition, ii. or who by any such process alters the quality of any such raw materials or manufactured or partially manufactured products so as to reduce it to marketable shape or prepare it for use as food for human or animal consumption, iii. or who by any such process combines any such raw material or manufactured products with other materials or products of the same or of different kinds and in such manner that the finished products of such process or manufacture can be put to a special use or uses to which such raw material or manufactured or partially manufactured products in their original condition could not have been put, and who in addition alters such raw material or manufactured products, iv. or combines the same to produce such finished products for the purpose of their sale or distribution to others and not for his own use or consumption.

- Food preparation includes carinderias, restaurants and other public eating place where foods already cooked are served.
- Interzonal movement the movement of people, goods, and services across areas placed under different Community Quarantine classifications
- Logistics encompasses the overall process of managing how resources are acquired, stored, and transported to their final destination.
- 8. Minimum public health standards guidelines set by the Department of Health (DOH) as well as the sector-relevant guidelines by government agencies, to aid all sectors in all settings to implement nonpharmaceutical interventions, which refer to public health measures that do not involve vaccines, medications, or other pharmaceutical interventions, which individuals and communities can carry out in order to reduce transmission rates, contact rates, and the duration of infectiousness of individuals in the population to mitigate COVID-19.
- 9. New normal refers to the emerging behaviors, situations, and minimum public health standard that will be institutionalized in common or routine practices and remain even after the pandemic while the disease is not totally eradicated through means such as widespread immunization. These include actions that will become second nature to the general public as well as policies such as bans on large gatherings that will continue to remain in force.
- Operational capacity refers to such a maximum number of employees or workers who can be permitted or required to physically report to work on-site in a particular office or establishment.
- 11. Safety/Health Officer -company-designated employee who is tasked with the following, among others: a) ensure that minimum public safety standards are complied with; b) monitor health of employees; and c) coordinate with the City or other regulatory agencies in relation to COVID-related health and safety protocols. All communications from the City of Mandaue shall be coursed through the Safety/Health Officer
- Skeleton workforce refers to the operational capacity which utilizes the smallest number of people needed for a business or organization to maintain its basic function.

SECTION 3. GENERAL GUIDELINES UNDER ECQ. - The following general policies shall be adopted during the Enhanced Community Quarantine (ECQ):

a) Essential Movement and Essential Travel - Movement outside of residence shall still be restricted, thus, only those essential purpose/travel, such as accessing basic necessities and services, shall be allowed outside of residence and only for those with valid

quarantine passes. Persons working in the establishments that are deemed open under ECQ shall also be allowed outside of residence.

- b) Transportation Restrictions Public transportation during the state of ECQ is NOT allowed, except: i. those provided by the LGU's, ii. public conveniences allowed by the LTFRB, iii. point-to-point company shuttle services within the City, iv. personal vehicles for persons/workers in permitted sectors/activity (2 persons per row) or motorcylces/bicycles (1 person).
- c) Checkpoints and Border Controls strict border control shall be maintained at all times to ensure that only those essential persons/travel, under existing Executive Orders, and workers of allowed businesses are allowed entry/exit.
- d) Proof of essential travel or person and those allowed businesses Persons traveling for essential purposes and those workers of allowed establishments under ECQ must be able to show documentary proof of showing that their purpose or work is among those allowed/essential during ECQ (business permit, company ID or certificate of employment, proof of residence, and the like).
- e) Barangay Participation All Barangay Officials, Tanods, and volunteers, in coordination with law enforcement agencies are enjoined to assist in the implemention of the regulations under this Order, such as, curfew protocols, regulated movement, and monitoring.
- f) Number Coding Scheme the existing number coding scheme for vehicles in the City shall be maintained. Vehicles of workers of establishments and businesses that are allowed to be open during ECQ shall be exempted from this coding scheme provided, social distancing is maintained, wearing of facemasks, and the driver can show documentary proof upon verification.
- g) Persons under Mandatory Stay-at-Home Any person below twenty-one (21) years old, those who are sixty (60) years old and above, those with immunodeficiency, comorbidities or other health risks, and pregnant women, including any person who resides with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services or for work in permitted industries and office.
- h) Minimum public standards shall be complied with at all times.
- Total Liquor Ban the total liquor ban imposed by the City of Mandaue shall remain effective. As such, the selling, transfer, distribution and/or consumption of any intoxicating beverage within the jurisdiction of Mandaue City is prohibited until declared otherwise.
- j) Curfew existing curfew rules will continue and must be strictly observed.

WORK OR OPERATE. Based on the Revised Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated May 15, 2020, the following are allowed to work or operate with a skeleton workforce unless a different operational capacity is provided:

A. Officials and employees of foreign diplomatic missions and international organizations accredited by the Department of Foreign Affairs (DFA), whenever performing diplomatic functions and subject to the guidelines issued by the DFA;

B. Industries involved in agriculture, forestry, fishery and their workers including farmers, Agrarian Reform Beneficiaries, fisherfolk, and agrifishery stores, and such other components of the food value chain, at

full operational capacity;

C. Private establishments and their employees involved in the provision of essential goods and services and activities in the value chain related to food and medicine production, such as but not limited to, public markets, supermarkets, grocery stores, convenience stores, laundry shops, food preparation establishments insofar as take-out and delivery services, water-refilling stations, hospitals, medical, dental, and optometry clinics, pharmacies, and drug stores. Provided, that for dental procedures, the wearing of Personal Protective Equipment (PPEs) by dentists and attendants shall be mandatory, with strict observance of infection prevention and control protocols;

- D. Manufacturing and processing plants of basic food products, medicine, vitamins, medical supplies, devices and equipment, essential products such as but not limited to soap and detergents, diapers, feminine hygiene products, toilet papers, wet wipes, and disinfectants. Provided, that establishments involved in the production, manufacturing, packaging, processing, and distribution of food may operate at a maximum of fifty percent (50%) of their respective workforces, unless the supply level of a basic food product warrants a higher capacity. In which case, the Department of Trade and Industry (DTI) is hereby authorized to approve the temporary increase of workforce capacity. Provided further, that manufacturers of medicines, medical supplies, devices and equipment, including but not limited to suppliers of input, packaging, and distribution, shall be allowed to operate at full capacity;
- E. Delivery services, whether in-house or outsourced, transporting food, medicine or other essential goods. Delivery of clothing, accessories, hardware, housewares, school and office supplies, as well as pet food and other veterinary products shall likewise be allowed.
- F. Banks, money transfer services, microfinance institutions and cooperatives, excluding pawnshops not performing money transfer, and credit cooperatives including their armored vehicles, if any;
- G. Power, energy, water, information technology and telecommunications supplies and facilities, including waste disposal services, as well as property management, and building utility services;
- H. Energy companies, their third-party contractors and service providers, including employees involved in electric transmission and distribution, electric power plant and line maintenance, electricity

market and retail suppliers, as well as those involved in the exploration, operations, trading and delivery of coal, oil, crude or petroleum and by-products (gasoline, diesel, liquefied petroleum gas, jet oil, kerosene, lubricants), including refineries and depots or any kind of fuel used to produce electricity;

1. Telecommunications companies, internet service providers, cable television providers, including those who perform indirect services such as the technical, sales, and other support personnel, as well as the employees of their third-party contractors doing sales,

installation, maintenance, and repair works;

J. Business process outsourcing establishments and export-oriented business with work from home, on-site or near site accommodation, or point-to-point shuttling arrangements. For this purpose, BPOs and their service providers and export-oriented businesses shall be allowed to install and transport necessary work-from-home equipment, to enhance their operations by deploying their workers under on-site or near-site accommodation arrangements, or provide point-to-point shuttle services from their near site accommodations to their offices;

K. Airline and aircraft maintenance employees, including pilots and

crew, ship captains and crew;

L. Media establishments at a maximum operational capacity of fifty percent (50%) of their total permanent staff complement as registered under the Department of Labor and Employment (DOLE), inclusive of reporters and other field employees, as accredited by the Presidential

Communications Operations Office;

M. Essential projects, whether public or private, such as but not limited to quarantine and isolation facilities for Persons under Monitoring, and suspect and confirmed COVID-19 patients, facilities for the health sector including those dealing with PUMs, and suspect and confirmed COVID-19 patients, facilities for construction personnel who perform emergency works, sewerage projects, water service facilities projects, and digital works. Priority public infrastructure projects, as well as priority private construction projects defined as those that refer to food production, agriculture, fishery, fish port development, energy, housing, communication, water utilities, manufacturing, and Business Process Outsourcing shall likewise be allowed to operate in accordance with guidelines issued by the DPWH;

N. Manufacturing companies and suppliers of equipment or products necessary to perform construction works;

- O. Employees of the Philippine Postal Corporation at a capacity necessary to maintain the prompt delivery of services to its clients;
- P. The Philippine Statistics Authority, at an operational capacity necessary to conduct data gathering and survey activities related to COVID-19 and the registration and implementation of the national identification (ID) system;

Q. Funeral and embalming services, provided that funeral service operators are directed to provide shuttling services and/or housing

accommodations for their personnel and staff;

R. Humanitarian assistance personnel from civil society organizations, non-government organizations, and United Nations-Humanitarian Country teams, as well as individuals performing relief operations to

augment the government's response against COVID-19 and other disasters or calamities that may occur. Provided, that they are authorized by the appropriate government or LGU;

- S. Pastors, priests, imams, or such other religious ministers whose movement shall be related to the conduct of necrological or funeral rites. In this connection, immediate family members of the deceased from causes other than COVID-19 shall be allowed to move from their residences to attend the wake or interment of the deceased upon satisfactory proof of their relationship with the latter and social distancing measures;
- T. Veterinary clinics;
- U. Security personnel;
- V. Hotels or similar establishments are allowed to operate only if they are accommodating the following:
  - guests who have existing booking accommodations for foreigners as of May 1, 2020;
  - guests who have existing long-term bookings;
  - iii. distressed Overseas Filipino Workers (OFW) and stranded Filipinos or foreign nationals;
  - iv. repatriated OFWs in compliance with approved quarantine protocols;
  - v. non-OFWs who may have been required to undergo mandatory facility-based quarantine; and
  - vi. healthcare workers and other employees from exempted establishments under the Omnibus Guidelines of the Inter-Agency Task Force, applicable Memoranda from the Executive Secretary, and this Executive Order,
- W. Mass gatherings such as, but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, community assemblies, religious gatherings, and non-essential work gatherings shall be prohibited; and
- X. Residential or face-to-face classes at all levels shall be suspended for the duration of the ECQ;

SECTION 5. GENERAL BUSINESS OPERATIONS GUIDELINES. All business establishments and the general public are advised to follow these minimum public health standards, in addition to the Department of Health issuances which shall form as business contigency health safety protocol, starting from the duration of the ECQ, and onwards:

Section 5.1. Mandatory wearing of masks in public places and workplaces:

- a. Face masks must be worn at all times and removed only when eating or drinking;
- b. Employers shall provide the appropriate face masks for workers; and
- c. Whenever cloth masks are used, the washable type shall be worn but additional filter material inside the masks should be added.

**Section 5.2.** Health symptoms questionnaire must be accomplished by all employees and submitted to the guard or designated safety officer prior to entry:

 Temperatures must be checked and recorded in the health symptoms questionnaire;

b. For any personnel with temperature exceeding 37.5 degrees Celsius, even after a five-minute rest, or if the response in the questionnaire needs further evaluation by the clinic/medical staff, the employee shall be isolated in an area identified by the company and not allowed to enter its premises;

 The isolation area should be well-ventilated and disinfected frequently.

d. Clinic staff assigned to assess the workers held in the isolation area shall be provided with appropriate medical grade PPEs by the establishment which shall include, but not limited to, face masks, goggles, face shields, and gloves; and disinfectant foot baths are to be provided at the entrance if practicable; and

e. Should there be a long queue outside the office or store premises, physical distancing of one meter should be observed at all times.

Section 5.3. Hand washing/sanitizing stations must be available in places frequented by the public or those in high-touch areas:

 All washrooms and toilets must have sufficient clean water and soap;

 Sanitizer must be made available in corridors, conference areas, elevators, stairways and areas where workers pass; and

c. All work areas and frequently handled objects such as doorknobs and handles, shall be cleaned and disinfected regularly, at least once every two hours.

Section 5.4. Mandatory physical and social distancing measured at least one (1) but preferably two (2) meters between individuals in the workplace:

 Eating in communal areas is discouraged. It is best to eat in individual work area and all wastes shall be disposed properly;

- b. If eating in individual work areas is not possible, the employer shall ensure that physical distancing is maintained in dining areas with one worker per table and one-meter distance per worker:
- Conversation without masks during meal times is discouraged;
- Tables and chairs shall be cleaned or disinfected after every use of the area and before as well as the end of the work day; and
- e. Canteens and kitchens should be cleaned and disinfected regularly.

Section 5.5. Minimum contact shall be observed:

- Alternative work arrangements such as working-hour shifts and work from home arrangements on rotation basis, where feasible is highly encouraged;
- Prolonged face-to-face interaction between workers and clients are discouraged and masks shall be worn at all times;

Meetings needing physical presence shall be kept at a minimum number of participants and with short duration. Videoconferencing shall be utilized for lengthy discussions among workers;

d. Office tables should be arranged in order to maintain proper

physical distancing;

 Workstation layout should be designed to allow for unidirectional movement in aisles, corridors or walkways;

 The number of people inside an enclosed space such as the rooms or stores, shall be limited. Elevator use should consider physical distancing and limit the number of persons inside;

g. Use of stairs is encouraged and if there are two accessible stairways, one stairway may be used exclusively for going up

and another for going down;

h. Online systems is highly encouraged and shall be utilized for clients needing assistance from offices including the use of videoconferencing; and roving officers shall always ensure physical distancing and observance of minimum health protocols.

Section 5.6. In the event that a worker is suspected as having COVID-19, the following shall be observed:

- a. The worker shall immediately proceed to the isolation area designated in the workplace and his/her mask must never be removed;
- b. Clinic personnel attending to the workers should wear appropriate PPEs and if needed, the worker must be transported to the nearest hospital. Company protocols for transport of suspect COVID-19 cases and for PCR testing shall be in place.

c. Decontamination of workplace must be done, to wit:

- Workplace shall be decontaminated with appropriate disinfectant (e.g. chlorine bleaching solution and 1:100 phenol based disinfectant);
- Work may resume after 24 hours, reckoned from time of decontamination;
- Workers present in the work area with the suspect COVID-19 worker shall go undergo 14-day home quarantine with specific instructions from clinic staff on monitoring of symptoms and possible next steps; and
- If suspect COVID-19 worker has negative swab test results, he and his co-workers may be allowed to report back to work.

Section 5.7. The placement of relevant on-site signages and online information materials bearing reminders to practice physical distancing, regular hand washing and sanitizing, medical and health information, updates on local cases and initiatives of the government as well as directions to the appropriate hand washing and sanitizing stations, testing stations or facilities, quarantine facilities, and other such information:



**Section 5.8.** To help mitigate the risks faced by the garbage collectors, there shall be a mandatory disinfection of all types of wastes before they are primed for garbage collection.

Section 5.9. The implementation, monitoring, and maintenance of a planned schedule for pedestrians traveling to and from their respective workplaces in coordination with private sector entities within the local government's territorial jurisdiction and if possible or applicable, the chartering of various means of transporting workers to and from their respective destinations;

SECTION 6. MANDATORY REQUIREMENTS FOR RE-OPENING OF BUSINESSES. For monitoring and safety purposes, business establishments which are allowed to operate during the Enhanced Community Quarantine and would like to reopen, and those that have already been allowed earlier must apply for a Special Permit to Operate, the following steps must be observed:

- a) Apply for a MAYOR'S SPECIAL PERMIT TO OPERATE with the Business Permit and Licensince Office. Only those with Special Permit, in addition to their existing business permit, shall be allowed to operate their businesses. Existing business that were allowed to operate before the effectivity of this Executive Order shall be required to comply with these regulations and will be subject to post audit.
- b) To reduce human-to-human interaction, which increases the probability of spreading the virus, the application for the MAYOR'S SPECIAL PERMIT TO OPERATE business, shall be done online by filling up application forms and instructions for submissions, through:

- c) Applicants must accomplish and fill out the online application form and thereafter submit through email the following documents a) Names of all employees in the workplace, residence, age, position, schedule of work, b) Statement of Management Responsibility for maintaining workplace health standards, c) Workplace Health Contingency Plan, and d) Name and contact number of designated Safety/Health Protocol Officer for business establishments with more than ten (10) employees. (Sample downloadable templates are available in the site).
- d) The City, through the Business Permits and Licensing Office (BPLO) shall evaluate the application, communicate with the applicants, and issue the Mayor's Special Permit to Operate.
- e) The BPLO will email the SPECIAL PERMIT TO OPERATE to the concerned business establishment for their printing which must be

displayed at a conspicuous place, along with its valid business permit, for post audit.

- f) A Joint Inspection Team or authorized City Inpectors shall conduct a post-audit to check whether business establishments have the Special Permit to Operate and are following the Safety Protocols and Business Operation Guidelines and other necessary documents under this Executive Order.
- g) The City reserves the right to cancel or revoke the previously issued SPECIAL PERMIT TO OPERATE, including the business permit, and closure of businesses in case of violation of this Executive Order.
- h) Applicants who have no access to email online platforms may be assisted by calling the BPLO Office, Tel No: 230-4500 or Cellphone No. 0917 354 3163
- i) Businesses that are allowed to open under lower risk classification, as per IATF guidelines, MAY start submitting their applications through the same web portal in advance. But may only operate after they are issued the Special Permit to Operate and once they are allowed under IATF classification.

SECTION 7. TESTING AND MONITORING FOR RETURNING EMPLOYEES. To control the spread and minimize transmission of the virus, the City of Mandaue STRONGLY ENCOURAGES all employers to subject all their returning working employees or a sampling thereof, to be deployed to be subjected to Rapid Anti-body Diagnostic Testing and/or Confirmatory RT-PCR Testing for Covid-19 following the guidelines under DOH Memorandum Order No. 2020-0220.

In addition, as part of monitoring, employers must screen their returning employees/workers for influenza-like symptoms and those that have relevant history of travel or exposure, such as those coming from areas that have high Covid-19 cases, to prevent possible infection.

SECTION 8. MONITORING OF PRIVATE COMMERCIAL AND INDUSTRIAL WORKPLACES. The Business Permit and Licensing Office (BPLO) in cooperation with the Philippine National Police (PNP) and related LGU-regulatory offices, as may be ordered by the City Mayor, are directed to monitor and implement the provisions of this Order. Barangays are also empowered to conduct monitoring and inspection of businesses in their jurisdiction to ensure compliance to the orders set herein.

To this end, in the interest of public health monitoring, and to assist authorities in the conduct of contact tracing for positive, suspected or probable Covid-19 cases, the following measures shall be made:

a. The City of Mandaue shall maintain a database profiling of all the private commercial and industrial, including other forms of business, operating in its areas of jurisdiction which shall include information such as the number of employees, working hours, workplace

conditions/office floor areas, addresses of employees, work schedules, and the like;

- b. All private commercial, industrial, and other forms of business operating within the territorial jurisdiction must have a Workplace Health Contingency Plan which shall detail the said business's compliance with the necessary safeguards and the Universal Safety Measures identified above prior to their resumption of operations. Essential business operations which have remained open and operational with a skeleton workforce during the Enhanced Community Quarantine period shall also be required to prepare Workplace Health Contingency Plan which shall be required from them during the conduct of post audit.
- c. Finally, by applying for a SPECIAL PERMIT TO OPERATE, the business establishment/ applicant signifies that he/she is a law abiding citizen and taxpayer and will comply with all the requirements and regulations set forth by law. The business establishment will allow any representative of the LGU regulatory office or the BPLO to inspect the place of business and perform their functions pursuant to their regulatory mandates and collect necessary data relevant to the prevention and control of the virus during this pandemic.

SECTION 9. INTERZONAL AND INTRAZONAL MOVEMENT. This section shall apply to the transit of people and goods from an ECQ area to a GCQ and vice versa, and from/to an ECQ Zone.

 The non-essential entry and exit of people to and from the ECQ Zone shall be prohibited except;

a. Health and emergency frontline service personnel,

- Government officials and government frontline personnel,
- c. Duly-authorized humanitarian assistance actors (HAAs)
- d. Persons travelling for medical or humanitarian reasons,
- Persons transiting to the airport for travel abroad,
- Workers in allowed establishments and persons providing essential goods and services and public utilities,

g. Essential skeleton workforce,

- h. Repatriated OFWs and non-OFWs returning to their residences,
- Other persons transported through the efforts of the national government upon conduct of necessary quarantine protocols and in concurrence with the receiving LGUs.
- 2. The movement of all types of cargoes by land, air, or sea within and across the areas placed under ECQ or GCQ shall be unhampered. Workers in the logistics sector, such as cargo, trucking and port operations shall likewise be allowed to transit across areas placed under ECQ or GCQ, provided that a maximum of five (5) personnel may operate cargo and delivery vehicles by land, with or without load.
- The Philippine National Police (PNP) retains its authority to conduct inspection procedures in checkpoints for the purposes of ensuring



that protocols on strict home quarantine are observed, while ensuring that movement of essential goods are unhampered.

- 4. The non-essential entry of persons to Mandaue City, shall be prohibited, except for those permitted to render work or conduct activities inside the ECQ zone (See Section 4). Considering, however, that Mandaue City is immediately adjacent to Consolacion and Lapu-Lapu City, and access to the entire province, which are now categorized as low-risk areas or under General Community Quarantine (GCQ), the following rules shall be followed:
  - a. Residents of Mandaue City who are now allowed to work in GCQ areas may be allowed to exit Mandaue City, this shall be considered as an "essential exit". Subject, however, to the border protocols and requirements of the receiving Cities/Municipalities.
  - b. Workers who were allowed "essential exit", as mentioned above, shall be allowed re-entry to Mandaue City, provided they can show proof of their residence (e.g. certication issued by the Barangay where they reside or identification cards)
  - c. BPO's and export-oriented businesses shall maintain current working arrangements: on-site arrangement, near-site arrangement, and work-from-home, and may be allowed pointto-point shuttle services only from their near site accommodations to their offices.
  - d. Workers/persons who come from low risk areas or GCQ areas may enter the City for essential purpose or allowed work, as mentioned under Section 4, this shall be considered as "essential entry". Provided that the employee can show documentary proof (business permit, identification card or certificate of employment). Provided further, that the employee shall still be subject to the re-entry protocols of his/her pointof-origin zone (GCQ).
  - e. Workers/persons from GCQ areas that are passing through Mandaue City to go to another GCQ area (e.g. Consolacion to Lapu-Lapu City, vv.) may be allowed entry/exit provided they are can show proof that they are working in allowed establishments/activities, such as, identification card or certificate of employment, business permit, and other documents that may be required by the receiving LGU. In addition, the passing through person/employee must have a document to prove his residence to be able to return to his/her point of origin. Provided further, that the employee shall still be subject to the re-entry protocols of his/her point-of-origin zone (GCQ).
  - The non-essential exit of persons from Mandaue City shall be prohibited, except those temporarily allowed entry in the URLUES

aforementioned provisions. Furthermore, those authorized to render work or perform activities in Mandaue City as mentioned in Section 4, shall be allowed to exit and move across areas placed under any form of community quarantine to render or perform said work or activities, subject to the border protocols of such zones.

SECTION 10. NEW PUBLIC MARKET SCHEDULE. To complement the number coding scheme (ODD/EVEN) and allow the people from the specified Barangays options to use their vehicles to go to the Mandaue City Public Market area, there shall hereby be a new schedule for the Barangays, furthermore, the Public Market shall now be closed on SUNDAYS for decontamination, thus:

SECTION 11. VIOLATIONS. Violation of any provision of this Order and other earlier Executive Orders issued in relation to the Covid-19 pandemic, shall be subject to penalty pursuant to existing national law and local ordinances, without prejudice to the revocation of any special permit or business permits issued, and the closure of the business establishment.

SECTION 12. INCORPORATION CLAUSE. All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly

constitued authorities of the Republic of the Philippines, particularly the Inter-Agency Task Force for the Management of Emerginf Infectious Diseases, pertaining to public health and Covid-19 are hereby incorporated herein and made integral parts hereof.

SECTION 13. SEPARABILITY CLAUSE. If any part or provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected shall remain valid and subsisting.

SECTION 14. REPEALING CLAUSE. All issuances inconsistent herewith are hereby superseded accordingly.

**SECTION 15. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain in force unless otherwise superseded or modified by subsequent Executive Orders and other issuances.
