"AN ORDER DECLARING A STATE OF GENERAL COMMUNITY QUARANTINE (GCQ) IN CEBU CITY AND PROVIDING GUIDELINES THERETO"

WHEREAS, on March 16, 2020, President Rodrigo R. Duterte, recognizing that the Corona Virus Disease 2019 (COVID-19) pandemic constitutes a threat to national security, declared a State of Calamity throughout the Philippines through Proclamation No. 929;

WHEREAS, the Department of Health (DOH) has already reported a total of 56,528 total active cases and 1,962 deaths due to COVID-19, as well as 26,996 total reported recoveries in the country as of July 30, 2020;

WHEREAS, there are 8,966 COVID-19 total confirmed cases, 3,314 active cases, 5,159 recoveries and 493 deaths due to the COVID-19 in Cebu City as of July 30, 2020;

WHEREAS, on July 31, 2020, President Rodrigo Roa Duterte, in a televised address, announced that Cebu City will be under General Community Quarantine (GCQ) from August 1 to 15, 2020;

WHEREAS, the National Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) has issued an updated Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines to harmonize and codify existing policies to be applied to regions, provinces, cities, municipalities, and barangays under community quarantine;

WHEREAS, the City of Cebu adopts the President's pronouncement in order to gradually reopen the economy while also maintaining minimum public health standards. As such, there is a need to transition from Modified Enhanced Community Quarantine to General Community Quarantine in the City of Cebu;

NOW, THEREFORE, I, EDGARDO C. LABELLA, City Mayor of the City of Cebu, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. **DECLARATION OF GENERAL COMMUNITY QUARANTINE** (GCQ). The City of Cebu is hereby placed under a State of General Community Quarantine (GCQ) effective on 12:01 A.M. of August 1, 2020 until 11:59 P.M. of August 15, 2020, unless sooner lifted or withdrawn.

SECTION 2. **MINIMUM PUBLIC HEALTH STANDARDS.** Within the duration of the General Community Quarantine (GCQ) in the City of Cebu, all residents are hereby directed to obey, follow and abide strictly to minimum public health standards. These include the wearing of face masks in public and in the workplace at all times, frequent handwashing, good personal hygiene and coughing etiquette, regular disinfection of



personal and work spaces, and observance of strict physical distancing. Further, the following policies and guidelines shall be strictly observed for the duration of the GCQ:

A. MANDATORY STAY-AT-HOME ORDER. All persons in the City of Cebu during the effectivity of the GCQ shall, at all times, stay at home and movement outside their homes shall be allowed only for purposes of accessing basic necessities and services and for work in permitted offices or establishments as well as activities listed hereunder. Provided, that in accessing basic necessities and services only one (1) member of the household is allowed to go out for this purpose and shall bring with him/her at all times the Quarantine Pass duly issued by the Cebu City Government.

Any person below twenty-one (21) years old, those who are sixty (60) years old and above, those with immunodeficiencies, comorbidities, or other health risks, and pregnant women, including any person who resides with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services, or for work in industries and offices or such other activities permitted under GCQ.

The Stay-At-Home Order shall not apply to the following:

- Medical practitioners, officers, hospital staff, nurses and health volunteers for the purpose of rendering medical assistance and/or service;
- Emergency personnel;
- All authorized national and local government officials and employees;
- Drivers and personnel of delivery vehicles carrying all types of cargoes;
- e. Accredited media personnel;
- Farmers, fishermen, and agri-business personnel;
- Persons who seek medical attention or who are already admitted in any medical facility, provided that only one companion shall be allowed;
- Employees of exempted establishments as provided under Section 2-C hereof; and
- Such other persons as may be authorized by the Mayor or his duly authorized representative.

Law enforcement agencies, for this purpose, shall recognize any of the following IDs:

- IATF IDs issued by the regulatory agencies with jurisdiction over permitted establishments or persons;
- bona fide IDs and certificates of employments issued by establishments exempted from the strict home quarantine requirement;
- iii. Quarantine Pass issued by the City of Cebu; or
- Integrated Bar of the Philippines ID for lawyers who will provide legal representation necessary to protect rights of persons under custodial investigation to bail, and to counsel during inquest proceedings.



No other IDs or passes specifically exempting persons from community quarantine shall be required of workers of permitted establishments and/or offices without prejudice to requiring the presentation of other documents establishing the nature of their work.

Outdoor non-contact sports and other forms of exercise such as, but not limited to, walking, jogging, running, biking, golf, swimming, tennis, badminton, equestrian, range shooting, and skateboarding are allowed. Provided, that minimum public health standards such as the wearing of masks and the maintenance of social distancing protocols, and not sharing of equipment where applicable, are observed.

B. NON-DISRUPTION OF GOVERNMENT WORK. Work in all government offices may be at full operational capacity or under such alternative work arrangements as agencies may deem proper in accordance with the relevant rules and regulations issued by the Civil Service Commission (CSC). Provided, that for offices requiring employees to report physically, commissioned shuttle services as well as point-to-point transport services may be provided.

Accredited diplomatic missions and international organizations may operate at fifty percent (50%) capacity. Alternative work arrangements such as flexible work arrangements, compressed work week, telework, and telecommuting is strongly encouraged.

C. ALLOWED BUSINESSES. Industries or sectors are allowed to operate provided that they comply with the minimum public health standards and safety protocols at all times. Provided further that they abide by the latest and relevant guidelines issued by the IATF, Department of Trade and Industry (DTI), Department of Labor and Employment (DOLE), Department of Health (DOH), and other industry-specific guidelines as set by relevant regulatory agencies for the industry.

Only the following sectors or industries shall be allowed to operate within the specified operating capacity indicated:

At full operational capacity:

- i. Public and private hospitals;
- Health, emergency and frontline services, including dialysis centers, chemotherapy centers and the like;
- iii. Manufactures of medicines, medical supplies, devices and equipment, including suppliers of input, packaging and distribution;
- Industries involved in agriculture, forestry, and fishery and their workers, including farmers, Agrarian Reform Beneficiaries (ARBs), fisherfolk, and agri-fishery stores, and such other components of the food value chain;
- Delivery and courier services, whether in-house or outsourced, transporting food, medicine or other essential goods, including



clothing, accessories, hardware, housewares, school and office supplies, as well as pet food and other veterinary products;

- vi. Private establishments and their employees involved in the provision of essential goods and services, and activities in the value chain related to food, medicine and vitamins production, medical supplies, devices and equipment, and other essential products such as but not limited to soap and detergents, diapers, feminine hygiene products, toilet paper and wet wipes, and disinfectants. Such establishments shall include, but shall not be limited to, public markets, supermarkets, grocery stores, convenience stores, laundry shops, food preparation establishments insofar as take-out and delivery services, and water refilling stations;
- vii. Media establishments without need of additional accreditation;
- viii. Other medical, dental, rehabilitation, and optometry clinics, pharmacies or drug stores: Provided that there is strict observance of infection prevention and control protocols. Provided further, that dental procedures shall be limited to emergency cases only and that the wearing of full Personal Protective Equipment (PPEs) by dentists and attendants shall be mandatory. Provided finally that home service therapy for Persons with Disabilities (PWDs) shall be allowed;
 - ix. Veterinary clinics;
 - x. Banks, money transfer services, including pawnshops only insofar as performing money transfer functions, microfinance institutions, and credit cooperatives, including their armored vehicle services, if any;
- xi. Capital markets, including but not limited to the Bangko Sentral ng Pilipinas, and Securities and Exchange Commission, Philippine Stock Exchange, Philippine Dealing and Exchange Corporation, Philippine Securities Settlement Corporation, and Philippine Depository and Trust Corporation;
- waste disposal services, as well as property management and building utility services;
- xiii. Energy and power companies, their third-party contractors and service providers, including employees involved in electric transmission and distribution, electric power plant and line maintenance, electricity market and retail suppliers, as well as those involved in the exploration, operations, trading and delivery of coal, oil, crude or petroleum and by-products (gasoline, diesel, liquefied petroleum gas, jet oil, kerosene, lubricants), including gasoline stations, refineries and depots or any kind of fuel used to produce electricity;
- xiv. Telecommunications companies, internet service providers, cable television providers, including those who perform indirect services such as the technical, sales, and other support personnel, as well as the employees of their third-party



contractors doing sales, installation, maintenance and repair works;

- xv. Airline and aircraft maintenance, pilots and crew, and employees of aviation schools for purposes of the pilot's recurrent training for flight proficiency and type rating using simulator facilities; and ship captains and crew, including shipyard operations and repair;
- Manufacturing companies and suppliers of equipment or products necessary to perform construction works, such as cement and steel;
- The Philippine Postal Corporation, at an operational capacity necessary to maintain the prompt delivery of services to its clients;
- xviii. The Philippine Statistics Authority, at an operational capacity necessary to conduct data gathering and survey activities related to COVID-19 and the registration and implementation of the national identification (ID) system;
- xix. Business process outsourcing establishments (BPOs) and exportoriented businesses, without need to set up on-site or near-site accommodation arrangements;
- xx. Essential projects, whether public or private, such as but not limited to quarantine and isolation facilities for Persons under Monitoring (PUMs), and suspect and confirmed COVID-19 patients, facilities for the health sector including those dealing with PUMs, and suspect and confirmed COVID-19 patients, facilities for construction personnel who perform emergency works, flood control, and other disaster risk reduction and rehabilitation works, sewerage projects, water service facilities projects, and digital works. Priority public and private construction projects, defined as those that refer to food production, agriculture, fishery, fish port development, energy, housing, communication, water utilities, manufacturing and Business Processing Outsourcing (BPOs), shall likewise be allowed to operate in accordance with guidelines issued by the DPWH.
- Funeral and embalming services. Provided, there is shuttling service and/or housing accommodation for their personnel and staff;
- xxii. Humanitarian assistance personnel from civil society organizations (CSOs), non-government organizations (NGOs), and United Nations-Humanitarian Country Teams, as well as individuals performing relief operations to augment the government's response against COVID-19 and other disasters or calamities that may occur. Provided, they are authorized by the appropriate government agency;
- xxiii. Pastors, priests, rabbis, imams or such other religious ministers whose movement shall be related to the conduct of necrological or funeral rites. In this connection, immediate family members of the deceased who died from causes other than COVID-19 shall be allowed to move from their residences to attend the wake or

interment of the deceased upon satisfactory proof of their relationship with the latter, fully complying with social distancing measures during the activity;

- xxiv. Security personnel;
- Printing presses authorized by the Bureau of Internal Revenue or other appropriate agencies to print official receipts and other accountable forms;
- xxvi. Establishments engaged in repair and maintenance of machinery and equipment, including those engaged in the repair of computers and household fixtures and equipment; and
- xxvii. Real estate activities limited to leasing only;
- Rental and leasing, other than real estate, such as vehicles and equipment for permitted sectors;
- xxix. Employment activities that involve the recruitment and placement for permitted sectors; and
- xxx. Housing services activities, such as but not limited to plumbing, roofing, and electrical works.
- At anywhere between fifty percent (50%) up to full operational capacity, and without prejudice to work-from-home and other alternative work arrangements:
 - Category II Industries mining and other manufacturing, and electronic commerce companies, as well as other delivery, repair and maintenance, and housing and office services;
 - b. Other manufacturing industries classified as beverages, including alcoholic drinks, electrical machinery, wood products and furniture, non-metallic products, textiles and clothing/wearing apparels, tobacco products, paper and paper products, rubber and plastic products, coke and refined petroleum products, other non-metallic mineral products, computers, electronic and optical products, electrical equipment, machinery and equipment, motor vehicles, trailers and semi-trailers, other transport equipment, and others;
 - Other real estate activities;
 - Administrative and office support such as, but not limited to, providing photocopying and billing services;
 - e. Management consultancy services or activities;
 - f. Recruitment and placement agencies for overseas deployment;
 - g. Advertising and market research;
 - Computer programming and information management services;
 - i. Publishing and printing services;
 - j. Film, music and television production;
 - k. Photography, fashion and industrial, graphic and interior design;
 - Wholesale and retail trade of vehicles and their parts and components;
 - Repair and maintenance of vehicles as well as its parts or components, including car wash services;



- Malls and commercial centers, subject to the guidelines issued by the DTI;
- Dining establishments and restaurants, subject to guidelines issued by the DTI;
- Barbershops and salons, subject to guidelines issued by the DTI;
- q. Hardware stores;
- r. Clothing and accessories;
- Bookstore and school and office supplies;
- t. Baby or infant care supplies;
- Pet food and pet care supplies;
- Information technology, communications and electronic equipment;
- w. Flower, jewelry, novelty, antique and perfume shops;
- Toy stores, provided, that their playgrounds and amusement areas, if any, shall remain closed;
- Firearms and ammunition trading establishments, subject to strict regulation of the PNP-Firearms and Explosives Office; and
- z. Pastors, priests, rabbi, imams and other religious ministers insofar as providing home religious services to households. Provided that proper protocols shall be observed, such as social distancing, wearing of face masks and the like.
- At anywhere from skeleton workforce to fifty percent (50%) operational capacity, and without prejudice to work-from-home and other alternative work arrangements:
 - Category III Industries financial services, legal and accounting, and auditing services, professional, scientific, technical, and other non-leisure services, and other non-leisure wholesale and retail establishments.

The foregoing lists of sectors and industries per category are illustrative. Specific industries under each category are reflected in a separate document issued by the DTI which shall contain the updated guidelines to implement gradual increase of operational and venue capacity including operation hours, without diminution of the current capacities and hours previously allowed. In any case, the latest and updated classifications and guidelines issued by the DTI shall prevail over those laid out in this Order.

- D. SUBMISSION OF DOCUMENTS FOR BUSINESSES. Businesses allowed to operate within the GCQ Period, including those already operating prior to the GCQ, shall fill out a Business Monitoring Form (BMF) and submit the following documents:
 - Employee Information including the appointment of a designated Health Infection and Prevention Control Officer (HIPCO) who shall be the point person for all health-related concerns of the company;



- Statement of Management Responsibility for Maintaining Workplace Health Standards, duly signed; and
- iii. Workplace Health Contingency Plan

The BMF, as well as sample forms can be downloaded, filled out, and submitted online via: https://sites.google.com/view/bplocebucity.

A Special Permit to Operate is not required for businesses to operate during the GCQ Period. The filling out of the BMF and submission of the necessary documents shall be enough for their resumption or continued operation.

Further, non-submission of the monitoring form and necessary documents, as well as fraudulent or inaccurate declarations, and non-compliance of the Work Health Contingency Plan and the minimum health standards as may be established by concerned and appropriate agencies such as the IATF, DOH, DOLE, and DTI shall be grounds for suspension and/or revocation of their business permits.

E. MONITORING OF EMPLOYEES IN ALLOWED BUSINESSES. The private sector is encouraged to adopt stricter health standards concerning their own operations. The HIPCO shall be the point person to implement such health standards as well as proper contact tracing protocols.

In addition, as part of monitoring, employers must screen their returning employees/workers for influenza-like symptoms and those that have relevant history of travel or exposure, such as those coming from areas that have high COVID-19 cases, to prevent possible infection.

For safety reasons, in the unfortunate event that an employee is found positive for COVID-19, the business establishment shall: 1) immediately suspend operations and implement containment and disinfection protocols; 2) test all employees that have exposure to the COVID-19 positive employee at the expense of the employer; and 3) secure a clearance from the City Health Department and the Business Permit and Licensing Office before resumption of operations.

The City Government of Cebu reserves the right to conduct random testing of employees of companies to ensure compliance to minimum public health standards and impose sanctions to erring establishments.

F. MALL OPERATIONS. Limited operations in malls and shopping centers shall be allowed, except for leisure establishments and services which shall continue to be closed. Provided, that establishments and services allowed to operate in malls and shopping centers may only operate at a capacity consistent with Section 2 (C) of this Order. Provided further, those below twenty-one (21) years old, and those sixty (60) years old and above and those with immunodeficiency, comorbidity, or other health risks, and pregnant women, including any person who resides with the aforementioned, may not enter malls and shopping centers except when indispensable under the circumstances for obtaining



essential goods and services or for work in establishments located therein. Provided finally, that operations of malls and shopping centers shall be subject to the guidelines of the DTI.

- G. HOTEL OPERATIONS. No hotels or accommodation establishments shall be allowed to operate, except those accommodating the following:
 - Guests who have existing booking accommodations for foreigners as of 01 May 2020;
 - Guests who have existing long-term bookings;
 - Distressed Overseas Filipino Workers (OFWs) and stranded Filipinos or foreign nationals;
 - iv. Repatriated OFWs in compliance with approved guarantine protocols;
 - Non-OFWs who may be required to undergo mandatory facility-based quarantine; and
 - vi. Health care workers and other employees from exempted establishments under the present Executive Order.

Provided that accommodation establishments may operate only upon the issuance of a Certificate of Authority to operate by the Department of Tourism (DOT). Provided further that in all of the foregoing, hotel operations shall be limited to the provision of basic accommodation services to guests through an in-house skeleton workforce. Ancillary establishments within the premises such bars, gyms, spas, and the like, shall not be allowed to operate or to provide room service.

Restaurants and cafes therein are hereby allowed to operate at thirty percent (30%) venue capacity provided that it allows for social distancing protocols and that such establishments are compliant with the protocols prescribed by DOT, or by joint guidelines issued by the DTI, DOLE, and DOH, as appropriate. In this regard, the operation of these dine-in establishments is hereby allowed up to 9:00 PM. Provided finally, that accommodation establishments may prepare: (a) packed meals for distribution to guests who opt for the same; and (b) food orders for take-out and delivery only.

- H. PROHIBITED ESTABLISHMENTS AND OPERATIONS. Amusement, gaming, and all Category IV industries may not operate. Industries in Category IV are reflected in pertinent DTI issuances.
- I. CONSTRUCTION PROJECTS. All public and private construction projects shall be allowed, but with strict compliance to the construction safety guidelines issued by the Department of Public Works and Highways (DPWH) for the implementation of infrastructure projects during the COVID-19 pandemic.
- J. PROHIBITION ON MASS GATHERINGS. Mass gatherings such as but not limited to movie screenings, concerts, sporting events, and other entertainment activities, community assemblies, and non-essential work gatherings shall be prohibited. Gatherings that are for the provision of critical government services



and authorized humanitarian activities while adhering to the prescribed minimum health standards shall be allowed. Religious gatherings shall be limited to not more than ten (10) persons until otherwise modified through subsequent issuances.

Visits to open-air memorial parks and cemeteries shall be limited to not more than ten (10) persons per group. The number of groups allowed at any given time shall be left to the discretion of the management of such memorial parks and cemeteries taking into consideration minimum public health standards and social distancing.

- K. PUBLIC TRANSPORTATION. The road, rail, maritime, and aviation sectors of public transportation shall operate at a reduced operational and vehicle capacity in accordance with guidelines issued by the Department of Transportation (DOTr). Provided, that in all public transports, a strict one (1) meter distance between passengers shall be observed and appropriate engineering controls shall be in place.
- L. SHIP OPERATIONS AND INTER-ISLAND TRAVEL. Operations of passenger ships shall be allowed pursuant to the IATF Omnibus Guidelines on the Implementation of Community Quarantine and Maritime Industry Authority (MARINA) Advisory No. 2020-29 dated April 30, 2020.

By virtue thereof, all shipping companies, ship operators, ship charterers and all concerned may operate and travel to and from areas under GCQ. In no case shall travel to any port under ECQ be allowed. The same are also directed to observe at all times, whether on shore or onboard, strict social distancing of at least one (1) meter distance between any two persons at any given point of time.

The following general guidelines shall be adopted:

- Shipping companies, as soon as possible, devise an online scheme where passengers can procure and pay ticket;
- Cleanliness of ships, buildings and on-shore premises shall at all times be maintained;
- Companies are required to employ one health or medical health worker on-board and one on-shore who will supervise the checking and monitoring of body temperature of passengers, employees and crew;
- iv. Health or medical workers of companies shall establish a communication line with proper health authorities for the reporting and coordination of suspected COVID-19 cases;
- Isolation areas shall be provided on-shore and on-board where COVID-19 suspects shall be brought, monitored and medically attended; and
- Mass gatherings on-board and on-shore shall be prohibited;

Provided further, the following on-shore guidelines shall be adopted:

 Companies shall observe social distancing by installing visible social distancing marks outside and inside the terminal such as, but not limited to, queuing, ticketing, waiting and boarding areas;



- Handwashing/lavatory areas with sufficient water, soap, alcohol or disinfectant shall be provided at the main entrances of the premises and at strategic parts of the building for free use by passengers and employees;
- Disinfecting footbath shall likewise be provided in all entry and exit access points of the premises and building;
- iv. Companies shall ensure that the number of persons accommodated inside the terminal and within the premises shall only be enough for everyone to practice social distancing;
- Wearing of masks is mandatory for all passengers and employees at all times and in all areas;
- vi. Checking of body temperature is mandatory before passengers and employees are allowed entry into the premises and the building; and
- Persons inside cars entering the port premises shall also be subjected to mandatory body temperature checking and passing through disinfecting footbath.

Provided finally, that the following on-board guidelines shall be observed:

- Ships shall only be allowed to carry 50% of its regular on-board capacity. Provided that passengers shall at all times during the voyage, maintain one (1) meter distance apart. This one-meter distance shall also apply to crew on board. To emphasize social distancing on-board, visible markings shall be drawn where passengers and crew sit, gather and converge;
- Checking of body temperature is mandatory before passengers and crew are allowed to go on board;
- iii. Handwashing/lavatory areas with sufficient water, soap, alcohol or disinfectant shall be provided at the main entrance of the ship and at all strategic locations inside the ship for free use by the passengers and crew;
- Disinfecting footbath shall likewise be provided in all entry and exit access onboard for passengers and crew and a disinfecting matting on the ramp for rolling cargoes; and
- Wearing of masks is mandatory for all passengers and crew at all times during the voyage.

M. INTERZONAL AND INTRAZONAL MOVEMENT. The following guidelines for interzonal and intrazonal movement shall be adopted:

- Pursuant to the Reciprocity Agreement adopted by the Cities of Cebu, Mandaue and Lapu-Lapu, Cebu City shall honor any document issued by Mandaue City and Lapu-Lapu City to its residents to be allowed entry/exit through its borders, such as a Travel Pass, Vehicle Pass or Border Pass.
 - Further, for purposes of interzonal entry/exit of allowed businesses/employees/individuals coming from or returning to Mandaue City and Lapu-Lapu City or passing through, the following documents shall be sufficient documentary proof at border checkpoints and random



inspections: (a) company identification cards, (b) certificates of employment and business permits.

- The movement of all types of cargoes by land, air or sea within and across the City of Cebu shall be unhampered. Workers in the logistics sector, such as cargo, trucking, courier delivery and port operations shall likewise be allowed to transit. Provided that only a maximum of five (5) personnel may operate cargo and delivery vehicles by land, with or without load.
- 3. The movement of the following persons within Cebu City shall be permitted:
 - a. Health and emergency frontline services personnel;
 - Government officials and government frontline personnel;
 - Duly-authorized humanitarian assistance actors (HAAs);
 - d. Persons traveling for medical or humanitarian reasons;
 - e. Persons going to the airport for travel abroad;
 - Returning or repatriated OFWs and other Overseas Filipinos (OFs) returning to their places of residence;
 - g. Other persons transported through the efforts of the national government upon observance of the necessary quarantine protocols and with the concurrence of the receiving LGUs; and
 - Anyone crossing zones for work permitted in the zone of destination and going back home.

Authorized shuttle vehicle services shall be allowed to travel within and across areas placed under any form of community quarantine, with priority given to persons rendering health and emergency frontline services.

Land, air or sea travel by uniformed personnel, government officials and employees for official business with the corresponding travel authority and authorized HAAs, especially those transporting medical supplies and laboratory specimens related to COVID-19 and other relief and humanitarian assistance, shall be allowed.

OFWs, students enrolled abroad and participants accepted in exchange visitor programs, permanent residents of foreign jurisdictions, and stranded foreign nationals, or those leaving for medical and other humanitarian reasons may leave for abroad through any of the airports or seaports in the country. Provided that this provision shall not be interpreted to allow outbound travel by Filipinos to countries where travel restrictions are in place. Provided further, that departing passengers may be accompanied by not more than one (1) person when traveling to any international port, who shall be allowed to return to his/her point of origin.

Repatriated OFWs or returning non-OFWs who have been issued a Department of Health (DOH) or City Health Office certificate of completion of fourteen (14) day facility-based quarantine, those who may be required to undergo a mandatory fourteen (14) day home quarantine or those who are issued with travel authority upon testing negative for COVID-19



whichever is earlier, shall be granted unhampered transit across zones en route to their final destination in the Philippines.

- N. LIQUOR BAN. A total liquor ban in all public places is hereby imposed within the City of Cebu upon the effectivity of this Order. As such, it shall be prohibited for any person to serve and/or drink intoxicating liquor in any public place within the City of Cebu during the entire period of the GCQ.
- O. MANDATORY WEARING OF FACE MASKS IN PUBLIC PLACES. All persons within the territorial jurisdiction of Cebu City are directed to wear the prescribed face masks at all times as provided under Executive Order No. 066, Series of 2020.
- P. CARBON PUBLIC MARKET COMPLEX SCHEDULE. The following schedule of admission of shoppers inside the Carbon Public Market Complex shall be based on the first letter of the family name of the shopper as follows:

The Carbon Public Market Complex shall be open to shoppers from 6 A.M. until 5 P.M. only. During this period, no vehicles shall be allowed entry into the Complex.

There shall be a designated delivery schedule of cargoes and supplies as determined by the Markets Operations Division (MOD), during which, trucks and vehicles may be allowed to enter. Authorized wholesalers, purchasers, and kumpradors shall be allowed entry within these schedules.

The Carbon Public Market Complex shall be closed to shoppers every Sundays. This day shall be dedicated for thorough cleansing and disinfecting activities to be done by the Markets Operations Division (MOD) as well as the individual vendors / sellers / concessionaires in their respective stalls or areas.

- Q. MANDATORY COVID-19 TESTING FOR PERSONS DEPRIVED OF LIBERTY (PDL) AND CHILDREN IN CONFLICT WITH THE LAW (CICL). The requirement for persons deprived of liberty (PDL) and children in conflict with the law (CICL) to undergo COVID-19 testing before admission into or release from the Cebu City Jail and the Cebu City Operation Second Chance Center, as provided under Executive Order Nos. 071 and 074, Series of 2020, respectively, shall continue to be in effect within the GCQ Period.
- R. CURFEW. The curfew schedule shall herein be adjusted and will start from 10:00 P.M. until 5:00 A.M. the following day. This shall apply to all persons and business establishments authorized to operate during the GCQ Period.



However, authorized persons outside of residence (APORs), those working in BPOs, health workers and government agencies providing frontline and emergency services are hereby exempted.

S. QUARANTINE PASS (QPASS) GUIDELINES. Quarantine Passes (QPass) duly issued by the City Government shall be presented by household members who wish to go out of their homes to access basic necessities and services. Authorized Persons Outside Residence (APORs) under the IATF-MEID guidelines as well as issuances by the Philippine National Police are exempted from this requirement.

The QPass shall only be allowed from 5:00 A.M. until 10:00 P.M. Further, QPass holders shall adhere to the following schedule:

Mondays, Wednesdays, and Fridays	QPasses with codes that end with ODD numbers (1, 3, 5, 7, and 9)

SECTION 3. **ENFORCEMENT.** The Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) are hereby directed to implement the full extent of this Executive Order.

Barangays officials and other force multipliers are likewise mandated to implement the full extent of this Order. Each barangay shall immediately establish checkpoints in strategic areas within in their respective areas of jurisdictions, in close coordination with law enforcement agencies.

Further, the Business Permit and Licensing Office (BPLO), Prevention Restoration Order Beautification and Enhancement (PROBE) Team, Cebu City Transportation Office (CCTO), Markets Operations Division (MOD), Department of Health (DOH), City Health Department (CHD), Vicente Sotto Memorial Medical Center (VSMMC), and Bureau of Jail Management and Penology (BJMP) are also mandated to implement the provisions of this Order which fall under their respective jurisdictions.

SECTION 4. **COVID-19 BEDS CENSUS.** To strictly monitor the critical utilization rate, all public and private hospitals within the City shall submit a daily census of occupancy documenting the following: (1) total regular bed capacity, (2) expanded COVID-19 bed capacity, (3) ICU bed capacity, and (4) dedicated COVID-19 ICU bed capacity. Further, daily census of in-patients and in emergency room patients specifically including their names, addresses, and contact details.

Level II Quarantine Facilities, including the Cebu City Quarantine Center, the Bayanihan Cebu Sacred Heart School Field Center and the IEC Field Center, the NOAH Complex, and Barangay Isolation Centers established throughout the City of Cebu shall likewise submit a daily census of their actual occupancies.

SECTION 5. **PENALTIES.** Violation of any provision of this Order and other earlier Executive Orders issued in relation to the COVID-19 pandemic shall be subject to penalties pursuant to existing national laws and local ordinances.

SECTION 6. **INCORPORATION CLAUSE.** All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines, particularly the IATF-MEID, pertaining to public health and COVID-19 are hereby incorporated herein and made integral parts hereof. In case of conflict, such laws, legal orders, rules and regulations shall take precedence over the provisions of this Executive Order.

SECTION 7. **SEPARABILITY CLAUSE.** Should any provision of this Executive Order be declared by a court of competent jurisdiction as invalid or unconstitutional, the remaining provisions not otherwise adversely affected thereby shall remain in full force and effect.

SECTION 8. **REPEALING CLAUSE.** Any and all executive orders, issuances, rules and regulations, memoranda of the City of Cebu or any part thereof which are inconsistent with the provisions of this Executive Order are hereby repealed, amended or modified accordingly.

SECTION 9. **EFFECTIVITY.** This Executive Order shall take effect immediately upon signing hereof and shall remain effective until revoked.
