"AN ORDER DECLARING A STATE OF MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ) IN CEBU CITY AND PROVIDING GUIDELINES THERETO"

WHEREAS, on March 16, 2020, President Rodrigo R. Duterte, recognizing that the Corona Virus Disease 2019 (COVID-19) pandemic constitutes a threat to national security, declared a State of Calamity throughout the Philippines through Proclamation No. 929;

WHEREAS, the Department of Health (DOH) has already reported a total of 36,260 total active cases and 1,614 deaths due to COVID-19, as well as 20,976 total reported recoveries in the country as of July 15, 2020;

WHEREAS, there are 7,685 COVID-19 positive cases of which 3,155 are active cases, 4,141 are recoveries and 389 deaths due to the COVID-19 in Cebu City as of July 15, 2020;

WHEREAS, on July 15, 2020, Presidential Spokesperson Harry Roque, in a live conference, announced that Cebu City has been classified under Modified Enhanced Community Quarantine (MECQ) until July 31, 2020 by the National Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID).

NOW, THEREFORE, I, EDGARDO C. LABELLA, City Mayor of the City of Cebu, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. **DECLARATION OF MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ).** The City of Cebu is hereby placed under a State of Modified Enhanced Community Quarantine (MECQ) effective immediately until 11:59 P.M. of July 31, 2020, unless sooner lifted or withdrawn.

SECTION 2. POLICY AND GUIDELINES UNDER THE MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ). Under the Modified Enhanced Community Quarantine (MECQ) in the City of Cebu, all residents are hereby directed to obey, follow and abide strictly to minimum public health standards and to the following policies and guidelines at all times for the duration of the MECQ:

A. MANDATORY STAY-AT-HOME ORDER. All persons in the City of Cebu during the effectivity of the MECQ shall, at all times, stay at home and movement outside their homes shall be allowed only for purposes of accessing basic necessities and services and for work in permitted offices or establishments as well as activities listed hereunder. Provided, that in accessing basic necessities and services only one (1) member of the household is allowed



to go out for this purpose and shall bring with him/her at all times the Ouarantine Pass duly issued by the Cebu City Government.

Any person below twenty-one (21) years old, those who are sixty (60) years old and above, those with immunodeficiencies, comorbidities, or other health risks, and pregnant women, including any person who resides with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services, or for work in industries and offices or such other activities permitted under MECQ.

The Stay-At-Home Order shall not apply to the following:

- Medical practitioners, officers, hospital staff, nurses and health volunteers for the purpose of rendering medical assistance and/or service;
- Emergency personnel;
- c. All authorized national and local government officials and employees;
- d. Drivers and personnel of delivery vehicles carrying all types of cargoes;
- e. Accredited media personnel;
- f. Farmers, fishermen, and agri-business personnel;
- Persons who seek medical attention or who are already admitted in any medical facility, provided that only one companion shall be allowed;
- Employees of exempted establishments as provided under Section 2-Characteristics.
- Such other persons as may be authorized by the Mayor or his duly authorized representative.

Law enforcement agencies, for this purpose, shall recognize any of the following IDs:

- IATF IDs issued by the regulatory agencies with jurisdiction over permitted establishments or persons;
- bona fide IDs and certificates of employments issued by establishments exempted from the strict home quarantine requirement;
- Quarantine Pass issued by the City of Cebu; or
- d. Integrated Bar of the Philippines ID for lawyers who will provide legal representation necessary to protect rights of persons under custodial investigation to bail, and to counsel during inquest proceedings.

No other IDs or passes specifically exempting persons from community quarantine shall be required of workers of permitted establishments and/or offices without prejudice to requiring the presentation of other documents establishing the nature of their work.

Individual outdoor exercise such as outdoor walks, jogging, running or biking are allowed within the MECQ period. *Provided*, that the minimum health standards and precautions such as the wearing of masks and the maintenance of social distancing protocols are observed.



B. NON-DISRUPTION OF GOVERNMENT WORK. Agencies and instrumentalities of the government, including GOCCs, may operate with a skeleton workforce in combination with other alternative work arrangements as approved by the head of agency unless a different operational capacity is required in agencies providing health and emergency frontline services, border control, and other critical services.

Agencies and their regional offices in the executive branch of the government shall issue accreditation, office or travel orders, to identify their respective skeleton workforces for critical services operating for the duration of the MECQ. Bona fide IDs issued by the respective agencies shall be sufficient for movement within the contained areas. Skeleton workforces may use official agency vehicles.

The judiciary, Office of the Ombudsman and Constitutional Commissions may operate and accredit their skeleton workforces, or implement any other alternative work arrangements as allowed under applicable rules.

Accredited diplomatic missions and international organizations shall be advised to operate under a skeleton workforce, without prejudice to alternative work arrangements as the said missions or organizations may deem proper.

- C. ALLOWED BUSINESSES. Industries or sectors are allowed to operate provided that they comply with the minimum public health standards and safety protocols at all times. Only the following sectors or industries shall be allowed to operate within the specified operating capacity indicated:
 - With full operational capacity:
 - a. Public and private hospitals;
 - Health, emergency and frontline services, including dialysis centers, chemotherapy centers and the like;
 - Manufactures of medicines, medical supplies, devices and equipment, including suppliers of input, packaging and distribution;
 - Industries involved in agriculture, forestry, and fishery and their workers, including farmers, Agrarian Reform Beneficiaries (ARBs), fisherfolk, and agri-fishery stores, and such other components of the food value chain;
 - Delivery and courier services, whether in-house or outsourced, transporting food, medicine or other essential goods, including clothing, accessories, hardware, housewares, school and office supplies, as well as pet food and other veterinary products;
 - f. Private establishments and their employees involved in the provision of essential goods and services, and activities in the value chain related to food, medicine and vitamins production, medical supplies, devices and equipment, and other essential products such as but not limited to soap and detergents, diapers,



feminine hygiene products, toilet paper and wet wipes, and disinfectants. Such establishments shall include, but shall not be limited to, public markets, supermarkets, grocery stores, convenience stores, laundry shops, food preparation establishments insofar as take-out and delivery services, and water refilling stations;

g. Media establishments without need of additional accreditation;

h. Other medical, dental, rehabilitation, and optometry clinics, pharmacies or drug stores: *Provided* that there is strict observance of infection prevention and control protocols. *Provided further*, that dental procedures shall be limited to emergency cases only and that the wearing of full Personal Protective Equipment (PPEs) by dentists and attendants shall be mandatory. *Provided finally* that home service therapy for Persons With Disabilities (PWDs) shall be allowed;

i. Veterinary clinics;

 Banks, money transfer services, including pawnshops only insofar as performing money transfer functions, microfinance institutions, and credit cooperatives, including their armored vehicle services, if any;

k. Capital markets, including but not limited to the Bangko Sentral ng Pilipinas, and Securities and Exchange Commission, Philippine Stock Exchange, Philippine Dealing and Exchange Corporation, Philippine Securities Settlement Corporation, and Philippine Depository and Trust Corporation;

 Water supply and sanitation services and facilities, including waste disposal services, as well as property management and

building utility services;

m. Energy and power companies, their third-party contractors and service providers, including employees involved in electric transmission and distribution, electric power plant and line maintenance, electricity market and retail suppliers, as well as those involved in the exploration, operations, trading and delivery of coal, oil, crude or petroleum and by-products (gasoline, diesel, liquefied petroleum gas, jet oil, kerosene, lubricants), including gasoline stations, refineries and depots or any kind of fuel used to produce electricity;

n. Telecommunications companies, internet service providers, cable television providers, including those who perform indirect services such as the technical, sales, and other support personnel, as well as the employees of their third-party contractors doing sales, installation, maintenance and repair

works

Airline and aircraft maintenance, pilots and crew, and employees
of aviation schools for purposes of the pilot's recurrent training
for flight proficiency and type rating using simulator facilities; and
ship captains and crew, including shipyard operations and repair;



p. Manufacturing companies and suppliers of equipment or products necessary to perform construction works, such as cement and steel:

q. The Philippine Postal Corporation, at an operational capacity necessary to maintain the prompt delivery of services to its

clients;

 The Philippine Statistics Authority, at an operational capacity necessary to conduct data gathering and survey activities related to COVID-19 and the registration and implementation of the national identification (ID) system;

 Business process outsourcing establishments (BPOs) and exportoriented businesses, without need to set up on-site or near-site

accommodation arrangements;

t. E-commerce companies;

u. Essential projects, whether public or private, such as but not limited to guarantine and isolation facilities for Persons under Monitoring (PUMs), and suspect and confirmed COVID-19 patients, facilities for the health sector including those dealing with PUMs, and suspect and confirmed COVID-19 patients, facilities for construction personnel who perform emergency works, flood control, and other disaster risk reduction and rehabilitation works, sewerage projects, water service facilities projects, and digital works. Priority public and private construction projects, defined as those that refer to food production, agriculture, fishery, fish port development, energy, housing, communication, water utilities, manufacturing and Business Processing Outsourcing (BPOs), shall likewise be allowed to operate in accordance with guidelines issued by the DPWH. Provided, however, that small-scale projects as defined by the DPWH shall not be allowed;

 Funeral and embalming services. Provided, there is shuttling service and/or housing accommodation for their personnel and

staff;

w. Humanitarian assistance personnel from civil society organizations (CSOs), non-government organizations (NGOs), and United Nations-Humanitarian Country Teams, as well as individuals performing relief operations to augment the government's response against COVID-19 and other disasters or calamities that may occur. *Provided*, they are authorized by the appropriate government agency;

x. Pastors, priests, rabbis, imams or such other religious ministers whose movement shall be related to the conduct of necrological or funeral rites. In this connection, immediate family members of the deceased who died from causes other than COVID-19 shall be allowed to move from their residences to attend the wake or interment of the deceased upon satisfactory proof of their relationship with the latter, fully complying with social distancing measures during the activity;

y. Security personnel;

 Printing presses authorized by the Bureau of Internal Revenue or other appropriate agencies to print official receipts and other accountable forms;

 aa. Establishments engaged in repair and maintenance of machinery and equipment, including those engaged in the repair of computers and household fixtures and equipment; and

bb. Real estate activities limited to leasing only;

cc. Rental and leasing, other than real estate, such as vehicles and equipment for permitted sectors;

dd. Employment activities that involve the recruitment and placement for permitted sectors; and

ee. Housing services activities, such as but not limited to plumbing, roofing, and electrical works.

- 2. The following offices, establishments or individuals conducting or providing the following activities or services are allowed to operate at fifty percent (50%) operational capacity, while encouraging work-from-home and other flexible work arrangements, where applicable:
 - a. Other manufacturing industries classified as beverages, including alcoholic drinks, electrical machinery, wood products and furniture, non-metallic products, textiles and clothing/wearing apparels, tobacco products, paper and paper products, rubber and plastic products, coke and refined petroleum products, other non-metallic mineral products, computers, electronic and optical products, electrical equipment, machinery and equipment, motor vehicles, trailers and semi-trailers, other transport equipment, and others;
 - Other real estate activities;
 - Administrative and office support such as, but not limited to, providing photocopying and billing services;
 - Other financial services not mentioned in Section 2 (C) (1) of this Order such as money exchange, insurance, reinsurance and noncompulsory pension funding;
 - e. Legal and accounting services;
 - f. Management consultancy services or activities;
 - g. Architectural and engineering activities, including technical testing and analysis;
 - Science and technology, and research and development;
 - i. Recruitment and placement agencies for overseas deployment;
 - Advertising and market research;
 - k. Computer programming and information management services;
 - Publishing and printing services;
 - m. Film, music and television production;
 - n. Photography, fashion and industrial, graphic and interior design:
 - Wholesale and retail trade of vehicles and their parts and components;
 - Repair and maintenance of vehicles as well as its parts or components, including car wash services;



- q. Malls and commercial centers, subject to the guidelines issued by the DTI:
- Dining establishments and restaurants, but for delivery and takeout only;
- s. Hardware stores;
- t. Clothing and accessories;
- u. Bookstore and school and office supplies;
- v. Baby or infant care supplies;
- w. Pet food and pet care supplies;
- Information technology, communications and electronic equipment;
- y. Flower, jewelry, novelty, antique and perfume shops;
- Toy stores, Provided, that their playgrounds and amusement areas, if any, shall remain closed;
- Firearms and ammunition trading establishments, subject to strict regulation of the PNP-Firearms and Explosives Office; and
- bb. Pastors, priests, rabbi, imams and other religious ministers insofar as providing home religious services to households. Provided that proper protocols shall be observed, such as social distancing, wearing of face masks and the like.

For purposes of the foregoing, transit by permitted persons to and from the above establishments anywhere within Cebu City shall be allowed. All other establishments not provided for under the present Executive Order shall be prohibited from operating.

- D. HOTEL OPERATIONS. No hotels or accommodation establishments shall be allowed to operate, except those accommodating the following:
 - Guests who have existing booking accommodations for foreigners as of 01 May 2020;
 - Guests who have existing long-term bookings;
 - Distressed Overseas Filipino Workers (OFWs) and stranded Filipinos or foreign nationals;
 - Repatriated OFWs in compliance with approved guarantine protocols;
 - e. Non-OFWs who may be required to undergo mandatory facility-based quarantine; and
 - Health care workers and other employees from exempted establishments under the present Executive Order.

Provided that accommodation establishments may operate only upon the issuance of a Certificate of Authority to operate by the Department of Tourism (DOT). Provided further that in all of the foregoing, hotel operations shall be limited to the provision of basic accommodation services to guests through an in-house skeleton workforce. Ancillary establishments within the premises such as restaurants, cafes, bars, gyms, spas, and the like, shall not be allowed to operate or to provide room service. Provided finally, that accommodation establishments may prepare: (a) packed meals



for distribution to guests who opt for the same; and (b) food orders for take-out and delivery only.

- E. PROHIBITED ESTABLISHMENTS AND OPERATIONS. The following shall not be allowed to operate within Cebu City during the period of MECQ:
 - Tourist destinations such as water parks, reservation service and related services;
 - b. Entertainment industries such as cinemas, theaters, and karaoke bars;
 - c. Kid amusement industries such as playroom and kiddle rides;
 - d. Libraries, archives, museums, cultural centers and internet cafes;
 - e. Gyms, fitness studios and sports facilities; and
 - Personal care services such as massage parlors, sauna, facial care and waxing.
- F. PROHIBITION ON MASS GATHERINGS. Mass gatherings such as but not limited to movie screenings, concerts, sporting events, and other entertainment activities, community assemblies, and non-essential work gatherings shall be prohibited. Gatherings that are essential for the provision of government services or authorized humanitarian activities while adhering to the prescribed minimum health standards shall be allowed. Religious gatherings shall be limited to not more than five (5) persons until otherwise modified through subsequent issuances.
- G. TRANSPORTATION RESTRICTIONS. All forms of public transportation shall be temporarily suspended except for commissioned shuttle services for employees of permitted offices or establishments, as well as point-to-point transport services provided by the government, giving priority to healthcare workers.

Private transportation such as company shuttles and personal vehicles utilized by persons authorized outside their residences are allowed subject to the guidelines provided by the Department of Transportation (DOTr). The use of bikes and other non-motorized transportation is strongly encouraged.

- H. UNHAMPERED MOVEMENT OF CARGO VEHICLES. Cargo vehicles as well as vehicles used by public utility companies, BPOs, and export-oriented establishments shall not be subject to an ID system and their movement shall be unhampered at all times.
- L MALL OPERATIONS. Limited operations in malls and shopping centers shall be allowed, except for leisure establishments and services which shall continue to be closed. *Provided*, that establishments and services allowed to operate in malls and shopping centers may only operate at a capacity consistent with Section 2 (C) of this Executive Order. *Provided further*, those below twenty-one (21) years old, and those sixty (60) years old and above and those with immunodeficiency, comorbidity, or other health risks, and pregnant women, including any person who resides with the aforementioned, may not enter malls and shopping centers except when indispensable under the circumstances for



obtaining essential goods and services or for work in establishments located therein. *Provided finally,* that such operations must comply with the guidelines of the DTI unless otherwise modified through subsequent issuances.

- J. MARKET AND ESSENTIAL RETAIL OPERATIONS. Supermarkets, public and private wet markets, grocery stores, agri-fishery supply stores, veterinary supply stores, pharmacies, drug stores, and other retail establishments engaged in the business of selling essential goods are strongly encouraged to extend their store operations to a maximum of twelve (12) hours. Such establishments are encouraged to adopt reasonable schemes to ensure compliance with strict social distancing measures. However, in no case shall such schemes involve narrowing the hours of their operations.
- K. INTERZONAL AND INTRAZONAL MOVEMENT. The following guidelines for interzonal and intrazonal movement shall be adopted:
 - Pursuant to the Reciprocity Agreement adopted by the Cities of Cebu, Mandaue and Lapu-Lapu, Cebu City shall honor any document issued by Mandaue City and Lapu-Lapu City to its residents to be allowed entry/exit through its borders, such as a Travel Pass, Vehicle Pass or Border Pass.

Further, for purposes of interzonal entry/exit of allowed businesses/employees/individuals coming from or returning to Mandaue City and Lapu-Lapu City or passing through, the following documents shall be sufficient documentary proof at border checkpoints and random inspections: (a) company identification cards, (b) certificate of employments and business permits.

- The movement of all types of cargoes by land, air or sea within and across
 the City of Cebu shall be unhampered. Workers in the logistics sector, such
 as cargo, trucking, courier delivery and port operations shall likewise be
 allowed to transit. *Provided* that only a maximum of five (5) personnel may
 operate cargo and delivery vehicles by land, with or without load.
- The movement of the following persons within Cebu City shall be permitted:
 - a. Health and emergency frontline services personnel;
 - b. Government officials and government frontline personnel;
 - c. Duly-authorized humanitarian assistance actors (HAAs);
 - d. Persons traveling for medical or humanitarian reasons;
 - e. Persons going to the airport for travel abroad;
 - Returning or repatriated OFWs and other Overseas Filipinos (OFs) returning to their places of residence;
 - g. Other persons transported through the efforts of the national government upon observance of the necessary quarantine protocols and with the concurrence of the receiving LGUs; and
 - Anyone crossing zones for work permitted in the zone of destination and going back home.

Authorized shuttle vehicle services shall be allowed to travel within and across areas placed under any form of community quarantine, with priority given to persons rendering health and emergency frontline services.

Land, air or sea travel by uniformed personnel, government officials and employees for official business with the corresponding travel authority and authorized HAAs, especially those transporting medical supplies and laboratory specimens related to COVID-19 and other relief and humanitarian assistance, shall be allowed.

OFWs, students enrolled abroad and participants accepted in exchange visitor programs, permanent residents of foreign jurisdictions, and stranded foreign nationals, or those leaving for medical and other humanitarian reasons may leave for abroad through any of the airports or seaports in the country. *Provided* that this provision shall not be interpreted to allow outbound travel by Filipinos to countries where travel restrictions are in place. *Provided further*, that departing passengers may be accompanied by not more than one (1) person when traveling to any international port, who shall be allowed to return to his/her point of origin.

Repatriated OFWs or returning non-OFWs who have been issued a Department of Health (DOH) or City Health Office certificate of completion of fourteen (14) day facility-based quarantine, those who may be required to undergo a mandatory fourteen (14) day home quarantine or those who are issued with travel authority upon testing negative for COVID-19 whichever is earlier, shall be granted unhampered transit across zones en route to their final destination in the Philippines.

- L. RESTRICTION OF INTER-ISLAND TRAVEL. Travelling into or transit through Cebu City from other islands shall be prohibited, except for the following:
 - 1. Authorized government officials and employees;
 - Health and emergency workers;
 - Law enforcement personnel, including the police, military and force multipliers;
 - Trucks and vehicles transporting all types of cargoes;
 - Those who may be authorized by the Mayor or his duly authorized representative.
- M. LIQUOR BAN. It shall be prohibited for any person to serve and/or drink intoxicating liquor in any public place within the City of Cebu during the entire period of the MECQ.
- N. MANDATORY WEARING OF FACE MASKS IN PUBLIC PLACES. All persons within the territorial jurisdiction of Cebu City are directed to wear the prescribed face masks at all times as provided under Executive Order No. 066, Series of 2020.



O. CARBON PUBLIC MARKET COMPLEX SCHEDULE. The following schedule of admission of shoppers inside the Carbon Public Market Complex shall be based on the first letter of the family name of the shopper as follows:

The Carbon Public Market Complex shall be open to shoppers from 6 A.M. until 5 P.M. only. During this period, no vehicles shall be allowed entry into the Complex.

There shall be a designated delivery schedule of cargoes and supplies as determined by the Markets Operations Division (MOD), during which, trucks and vehicles may be allowed to enter. Authorized wholesalers, purchasers, and kumpradors shall be allowed entry within these schedules.

The Carbon Public Market Complex shall be closed to shoppers every Sundays. This day shall be dedicated for thorough cleansing and disinfecting activities to be done by the Markets Operations Division (MOD) as well as the individual vendors / sellers / concessionaires in their respective stalls or areas.

P. TEMPORARY WAIVING OF FEES. As part of the Cebu City Government's efforts to support frontliners, the temporary waiver of the collection of parking fees in all City-Government operated pay parking spaces and facilities for medical and health workers, as provided under Executive Order No. 063, Series of 2020, is hereby extended within the duration of the MECQ.

In the same manner, to mitigate the socio-economic impact of the MECQ, the temporary waiver of the collection of market fees, as provided under Executive Order No. 057, Series of 2020, is also extended within the duration of the MECQ.

- Q. MANDATORY COVID-19 TESTING FOR PERSONS DEPRIVED OF LIBERTY (PDL) AND CHILDREN IN CONFLICT WITH THE LAW (CICL). The requirement for persons deprived of liberty (PDL) and children in conflict with the law (CICL) to undergo COVID-19 testing before admission into or release from the Cebu City Jail and the Cebu City Operation Second Change Center, as provided under Executive Order Nos. 071 and 074, Series of 2020, respectively, shall continue to be in effect within the MECQ Period.
- R. CURFEW. The curfew schedule shall herein be adjusted and will start from 8:00 P.M. until 5:00 A.M. the following day. This shall apply to all persons and business establishments authorized to operate during the MECQ Period. However, authorized persons outside of residence (APORs), those working in



BPOs, health workers and government agencies providing frontline and emergency services are hereby exempted.

S. QUARANTINE PASS (QPASS) GUIDELINES. Quarantine Passes (QPass) duly issued by the City Government shall be presented by household members who wish to go out of their homes to access basic necessities and services. Authorized Persons Outside Residence (APORs) under the IATF-MEID guidelines as well as issuances by the Philippine National Police are exempted from this requirement.

The QPass shall only be allowed from 6:00 A.M. until 8:00 P.M. Further, QPass holders shall adhere to the following schedule:

SECTION 3. **ENFORCEMENT.** The Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) are hereby directed to implement the full extent of this Executive Order.

Barangays officials and other force multipliers are likewise mandated to implement the full extent of this Executive Order. Each barangay shall immediately establish checkpoints in strategic areas within in their respective areas of jurisdictions, in close coordination with law enforcement agencies.

Further, the Business Permit and Licensing Office (BPLO), Prevention Restoration Order Beautification and Enhancement (PROBE) Team, Cebu City Transportation Office (CCTO), Markets Operations Division (MOD), Department of Health (DOH), City Health Department (CHD), Vicente Sotto Memorial Medical Center (VSMMC), and Bureau of Jail Management and Penology (BJMP) are also mandated to implement the provisions of this Order which fall under their respective jurisdictions.

SECTION 4. COVID-19 BEDS CENSUS. To strictly monitor the critical utilization rate, all public and private hospitals within the City shall submit a daily census of occupancy documenting the following: (1) total regular bed capacity, (2) expanded COVID-19 bed capacity, (3) ICU bed capacity, and (4) dedicated COVID-19 ICU bed capacity. Further, daily census of in-patients and in emergency room patients specifically including their names, addresses and contact details.

Level II Quarantine Facilities, including the Cebu City Quarantine Center, the Bayanihan Cebu Sacred Heart School Field Center and the IEC Field Center, the NOAH Complex, and Barangay Isolation Centers established throughout the City of Cebu shall likewise submit a daily census of their actual occupancies.

SECTION 5. **PENALTIES.** Violation of any provision of this Order and other earlier Executive Orders issued in relation to the COVID-19 pandemic shall be subject to penalties pursuant to existing national laws and local ordinances.

SECTION 6. **INCORPORATION CLAUSE.** All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines, particularly the IATF-MEID, pertaining to public health and COVID-19 are hereby incorporated herein and made integral parts hereof. In case of conflict, such laws, legal orders, rules and regulations shall take precedence over the provisions of this Executive Order.

SECTION 7. **SEPARABILITY CLAUSE.** Should any provision of this Executive Order be declared by a court of competent jurisdiction as invalid or unconstitutional, the remaining provisions not otherwise adversely affected thereby shall remain in full force and effect.

SECTION 8. REPEALING CLAUSE. Any and all executive orders, issuances, rules and regulations, memoranda of the City of Cebu or any part thereof which are inconsistent with the provisions of this Executive Order are hereby repealed, amended or modified accordingly.

SECTION 9. **EFFECTIVITY.** This Executive Order shall take effect immediately upon signing hereof and shall remain effective until revoked.
