**EXECUTIVE ORDER NO. 20 - A**  
Series of 2020

**ADOPTING PROTOCOLS AND GUIDELINES TO GOVERN TOURISM-RELATED ACTIVITIES THAT PROMOTE THE HEALTH AND WELLNESS OF AN INDIVIDUAL, ACCOMMODATION ESTABLISHMENTS, AND THE DINE-IN OF PERSONS IN RESTAURANTS.**

---

**WHEREAS**, on June 29, 2020, the IATF-MEID issued Resolution No. 50-A that placed the entire Province of Cebu under a *Modified General Community Quarantine* risk classification except for the City of Talisay, the Municipality of Consolacion, and the Municipality of Minglanilla that continue to remain under GCQ;

**WHEREAS**, on July 10, 2020, the Governor of Cebu issued Executive Order No. 20, Series of 2020, that defined the MGCQ protocols, standards, and guidelines to be observed by all persons within the Province of Cebu;

**WHEREAS**, in order to promote Cebu as a Health and Wellness Destination, tourism activities that support said purpose should be reactivated subject to strict protocols and guidelines;

**WHEREAS**, in several meetings where representatives from the different municipalities and component cities of the Province of Cebu, the Department of the Interior and Local Government, the Department of Health, and the Department of Tourism were present, protocols and guidelines were agreed relative to the regulation of tourism-related activities that promote the health and wellness of persons;

**WHEREAS**, it was also agreed that a *Cebu Provincial Tourism Task Force* shall be created to monitor compliance of the agreed protocols and guidelines;

**WHEREAS**, Republic Act (RA) No. 7160, otherwise known as the *Local Government Code of 1991*, states that provinces shall exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare, health, and safety, including the provisions of services to control communicable diseases;

**NOW, THEREFORE, I, GWENDOLYN F. GARCIA**, by the virtue of the powers and authority vested in by law, and congruent with the premises set forth above, do hereby order:

**SECTION 1. Permitted Activities.** Subject to the observance of applicable guidelines under Executive Order No. 20, Series of 2020,

persons within the Province of Cebu shall include, but not be limited to, the following:

- a. Canyoneering
- b. Island Hopping
- c. Snorkeling
- d. Diving
- e. Beach Activities
- f. Whaleshark Watching and Snorkeling
- g. Sightseeing
- h. Zipline Adventure
- i. ATV Riding
- j. Parasailing
- k. Hiking, Trekking, and Mountaineering
- l. Spelunking (Caving)
- m. Visiting Cultural Heritage Sites and Museums

**SECTION 2. General Guidelines.** All establishments engaged in the permitted activities above mentioned shall be allowed to operate subject to the observance of the following general guidelines and protocols:

**A. Activity Booking**

- i. To discourage walk-in tourists, pre-booking **MUST** be done prior to visiting the site attraction or destination using the centralized online booking portal managed by the *Cebu Provincial Tourism Task Force*.

Guests who arrive at the destination without bookings shall be assisted by the establishment to ensure that booking is done thru the portal before allowing them to participate in any activity.

- ii. Payments shall be made thru money transfer and e-wallet service.

Other cashless payment options shall be made available in the online booking portal.

Cash payments are strongly discouraged.

- iii. A Tourist Brief detailing on the rules and regulations to be followed, as well as a list of prescribed gear, shall be forwarded to guests upon confirmation of their bookings.
- iv. Tourists must be able to provide complete personal and travel information upon booking of the tour.
- v. Tour packages must be **FULLY PAID** before commencement of the tour.
- vi. After booking has been completed, and once the tour package has been fully paid, guests shall be sent a Radio-Frequency Identification (RFID) Confirmation Code thru

their emails, Facebook Messengers, Viber accounts, or any other similar messaging platform.

The RFID Confirmation Code shall be presented upon arrival for verification.

Once verified, each guest shall be given an RFID Bracelet that must be worn at all times for the duration of their stay at the tourist activity destination.

- vii. A tour package may include local transportation to and from the tourist destination, souvenir items, guides' fee, meals during the tour, entrance fee, and any other applicable fees.

Vehicles transporting guests to and from the destinations must not be air-conditioned. If this is not possible, an air purification system with *high efficiency particulate air (HEPA) filter and ionizer* shall be installed in vehicles.

The capacity of the purification system should be proportional to the size of the vehicle.

Established guidelines and protocols set by the Land Transportation Franchising and Regulatory Board (LTFRB) on maintaining physical distancing while inside vehicles must be followed.

## **B. Reception Areas**

- i. All personnel assigned at the reception area should wear a personal air purifier.
- ii. Health screening and other health protocols should be strictly observed.

Temperature checks shall be administered to all guests upon entry. Those exhibiting influenza-like symptoms shall immediately be turned over to the City or Municipal Health Officer for proper management and handling.

- iii. Physical distancing markers should be placed in visible areas with at least one (1) meter distance between each other to guide queuing guests.
- iv. Foot baths must be placed at the entrance of the reception area.
- v. Acrylic or glass barriers may be set up at the front desks.
- vi. Alcohol and alcohol-based hand sanitizers as well as tissue or paper towels must be made available by the establishment at all times.
- vii. An air-purification system with HEPA filter and ionizer shall be installed at the reception area.

The capacity of the air-purification system must be proportional to the size of the reception area.

- viii. The use of disposable water bottles is not allowed. Instead, guests shall be provided with a brand-new refillable water tumbler, the cost of which shall be part of the tour package, which they will use for the entire duration of the activity and may keep as a souvenir.

Refilling stations for water and/or turmeric-infused and honey-sweetened calamansi juice shall be made readily available to guests.

- ix. Washing areas must be visible from the entry point and within the premises of the reception area, provided that its architectural design must blend with the natural setting of the environment.
- x. Luggage and other personal belongings shall be disinfected with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- xi. Waste receptacles must be placed in conspicuous places within the reception area.
- xii. The reception area shall be regularly cleaned, disinfected, and sterilized with an *Ultraviolet Germicidal Light* after business hours.

#### **C. Welcoming of Visitors**

- i. Freshly squeezed juice that boost the immune system must be served to welcome guests at every site attraction or destination.

These should include turmeric or salabat tea, lemongrass juice, calamansi juice, and other similar drinks made from products that can be found locally.

- ii. Service crew should wear face masks, face shields, and personal air purifiers while serving food and drinks.
- iii. There shall be a daily report made to the local tourism officer on the number of tourists managed by the establishment.

The local tourism officer should submit a collated monthly report to the Cebu Provincial Tourism Office.

#### **D. Briefing and Orientation**

- i. Rules and regulations must be forwarded to guests upon confirmation of their bookings.

Said rules and regulations must also be presented to the guests before the start of the tour.

- ii. Personnel briefing the guests shall wear face masks, face shields, and personal air purifiers at all times.
- iii. Physical distancing shall be strictly observed at all times. Only 50% of the maximum seating capacity of the briefing area shall be occupied.
- iv. Floor markers shall be installed to guide guests in observing the physical distancing requirement.

#### **E. Management of Safety Gear and Equipment**

- i. There shall be a regular disinfection and sterilization of safety gears, facilities, equipment, and surroundings.
- ii. Gear and equipment that are rented out should, at the end of each use, be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

Properly sterilized equipment must be stored in sterilized and sealed containers which shall be labeled or tagged for easy identification.

A room within the establishment shall be designated solely for gear and equipment sterilization.

#### **F. Destination Workforce**

- i. The health of all personnel should be regularly checked prior to their work shift thru temperature checking and other applicable health checks. Those exhibiting influenza-like symptoms shall be referred to the City or Municipal Health Officer for proper handling and management.
- ii. Client-facing personnel, such as receptionists, waiters, busboys, and briefers, are required to wear face masks, face shields, and personal air purifiers.
- iii. Only LGU accredited operators and community guides will be allowed to operate.

#### **G. Personal Air Purifier**

All guests are required to wear personal air purifiers during the duration of the activity.

Guests without personal air purifiers may rent disinfected and sterilized personal air purifiers at the place of the destination activity.

#### **H. Souvenir Items**

In order to promote Cebu as a Health and Wellness Destination, souvenir shops and establishments are strongly encouraged to sell items that, as far as practicable, support the *Health Regimen and Safety Measures* prescribed under Section 7 of Executive Order No. 20, Series of 2020.

**SECTION 3. Guidelines for Activities.** The following protocols and guidelines shall be observed by establishments engaged in the activities mentioned below:

**A. Canyoneering**

- i. Operation shall be from 6:00 AM until 3:00 PM only.
- ii. A maximum height of thirty (30) feet shall be strictly enforced for waterfall jumping.
- iii. Groups will be composed of a maximum of five (5) persons to be accompanied by two (2) trained guides.

Only persons travelling together shall be allowed in a group.

- iv. Guides must strictly observe good personal hygiene and wear proper uniform.

When guiding, they must be equipped with a two-way communication device and safety and emergency equipment, such as, but not limited to, helmet, life vest, and other similar gear in accordance to appropriate equipment standards.

- v. Strict physical distancing shall be observed, with a seven-minute interval between each group.
- vi. There shall be a maximum limit of 300 persons per day in the area for canyoneering activities.
- vii. Selling of food and drinks is strictly prohibited.
- viii. Visitors must wear proper gear, such as helmet, life vest, canyoneering shoes, and other protective equipment that may be required AT ALL TIMES during any water activity. A list of the prescribed gear must form part of the brief sent to guests prior to the activity.
- ix. Gear and equipment that are rented out should, at the end of each use, be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- x. Canyoneering operators shall set aside one day of every week for cleanup and maintenance. The *Cebu Provincial*

*Tourism Task Force* shall be notified of the appointed day for supervision and monitoring.

**B. Island Hopping, Dolphin Watching, and Other Related Activities**

- i. Only boats or bancas (motorized or not) of boat operators duly accredited with the Department of Tourism and the Maritime Industry Authority and registered with the LGU shall be allowed to operate.

Regular monitoring shall be conducted by the Philippine Coast Guard and the PNP Tourist Police.

- ii. Only 50% of the boats or banca's maximum passenger carrying capacity shall be permitted.
- iii. Only persons travelling in the same group shall be allowed to board the boat or banca.
- iv. Alcohol and alcohol-based hand sanitizers must be present on board the boat or banca at all times.
- v. The full passenger capacity as well as the 50% passenger capacity of the vessel must be displayed at all times for transparency and for easy reference.
- vi. Passengers must wear complete safety gear, such as life vest, appropriate footwear, and other protective equipment that are in good condition AT ALL TIMES during any water activity. Guides must ensure that safety gears are worn correctly and securely.

Gear and equipment that are rented out should, at the end of each use, be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

- vii. Frequently touched surfaces of the vessel shall be regularly disinfected upon disembarkation and prior to embarkation.

**C. Snorkeling**

- i. Persons who intend to engage in snorkeling activities are required to purchase or bring their own mask and snorkel.

Masks and snorkels are not allowed to be rented out by the establishment but may be sold by the establishment.

- ii. Tourists shall bring their own towels and refillable water tumblers.

Towels and water tumblers shall not be rented out but may be sold by the establishment.

- iii. Spitting on snorkeling masks for defogging is strictly prohibited. For this reason, spray bottles with diluted baby shampoo shall be provided.
- iv. Customers shall not be allowed access to areas where equipment is stored.
- v. Gear and equipment that are rented out – fins, life jackets, and the like—should be regularly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- vi. Properly sterilized equipment must be stored in sterilized and sealed containers, which shall be labeled and tagged for easy identification.
- vii. Frequently touched surfaces of the vessel shall be regularly disinfected after every use.

#### **D. Diving Activities**

- i. All dive operators are required to be accredited with the Department of Tourism and Philippine Commission for Sports SCUBA Diving.

All diving protocols implemented by the operators should be in conformity with international diving standards.

- ii. Divers are strongly encouraged to purchase or bring their own masks, Buoyancy Control Devices (BCD), mouthpieces, snorkeling tubes, and other related gears to avoid sharing of equipment.

Masks, mouthpieces, and snorkeling tubes should neither be rented out nor shared but may be sold by the establishment.

- iii. Tourists shall bring their own towels and refillable water tumblers.

Towels and water tumblers shall not be rented out but may be sold by the establishment.

- iv. Only 50% of the boat or banca's maximum passenger carrying capacity shall be allowed.
- v. Only persons travelling in the same group shall be allowed to board the boat or banca.
- vi. The full passenger capacity as well as the 50% passenger capacity of the vessel must be displayed at all times to provide transparency and for easy reference.



- vii. Spitting on masks for defogging is strictly prohibited. For this reason, spray bottles with diluted baby shampoo shall be provided.
- viii. Customers shall not be allowed access to areas where equipment is stored.
- ix. Frequently touched surfaces of the vessel transporting the divers shall be regularly disinfected after every use.
- x. There shall be a regular sterilization of all diving gear that are rented out such as masks, BCDs, and related dive gear using *Ultraviolet Germicidal Light*. Instructions on the proper handling and use of sterilizing equipment must be STRICTLY OBSERVED.

Properly sterilized equipment should be stored in sterilized and sealed containers, which shall be labeled or tagged for easy identification.

Dive shop owners are strongly encouraged to purchase their own Ultraviolet Germicidal Irradiation equipment.

#### **E. Beach Activities**

- i. Only 50% of the maximum carrying capacity of the beach front area shall be occupied.
- ii. Food and drinks are not allowed on the beach.
- iii. Physical distancing must be followed at the premises and during swimming.
- iv. There shall be a regular sterilization of all rented beach gear and equipment using *Ultraviolet Germicidal Light*. Instructions on the proper handling and use of sterilizing equipment must be STRICTLY OBSERVED.

#### **F. Whaleshark Interaction**

- i. Operation shall be from 6:00 AM until 12:00 PM only.
- ii. A maximum daily limit of 1,000 guests shall be imposed.
- iii. Only 50% of the boat or banca's maximum passenger carrying capacity shall be allowed.
- iv. Only persons travelling in the same group shall be allowed to board the boat or banca.
- v. Boatmen must strictly observe good personal hygiene and wear proper uniform.
- vi. The full passenger capacity as well as the 50% passenger capacity of the vessel must be displayed at all times for transparency and for easy reference.

- vii. Life vests and other swimming equipment rented and used during the activity shall be regularly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- viii. Frequently touched surfaces of the boat or banca shall be regularly disinfected after every use.

#### **G. Sightseeing**

- i. Subject to the minimum health standards established under Executive Order No. 20, Series of 2020, and by the Department of Health, sightseeing of tourist sites and other attractions shall be allowed within the Province of Cebu.
- ii. Guests must be divided into groups before proceeding to the activity areas. Groups will be composed of a maximum of five (5) persons to be accompanied by one (1) trained guide, when applicable.  
  
Only persons travelling together shall be allowed in a group.
- iii. Only 50% of the maximum carrying capacity of the sightseeing area shall be used.
- iv. Guides must be equipped with a two-way communication device, safety and emergency equipment that are in accordance to the appropriate equipment standards.
- v. For waterfall sightseeing, the area shall be closed one day of every week, which will be set aside for the maintenance and upkeep of the vicinity. The *Cebu Provincial Tourism Task Force* shall be notified of the appointed day for supervision and monitoring.

Life vests and other equipment used during the waterfall sightseeing activity shall be regularly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

Selling of food and drinks is strictly prohibited.

Swimming in the waterfalls is also prohibited.

#### **H. Zipline Adventure**

- i. Only one (1) guest per cable line shall be allowed per trip.
- ii. Personnel of the establishment must wear face masks, face shields, and personal air purifiers at all times.

- iii. Safety gear worn by guests during the activity shall, after each use, be sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- iv. There shall be regular disinfection of the zipline platform and zipline gear.

#### **I. ATV Riding**

- i. Only one (1) guest per ATV bike shall be allowed per trip.
- ii. Personnel of the establishment must wear face masks, face shields, and personal air purifiers at all times.
- iii. Visitors must wear complete safety equipment such as helmet, life vest, shoes, and other protective equipment AT ALL TIMES for the duration of the activity.

A list of the prescribed gear must form part of the Tourist Brief sent to guests prior to the activity.

- iv. The gear and equipment that are rented out should, at the end of each use, be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- v. The ATV bike shall be regularly disinfected after each use.

#### **J. Parasailing**

- i. Only boat operators duly accredited with the Department of Tourism and the Maritime Industry Authority and registered with the LGU shall be allowed to operate. Regular monitoring shall be conducted by the Philippine Coast Guard and tourist police.
- ii. Only 50% of the boat's maximum passenger carrying capacity shall be permitted.
- iii. Only persons travelling in the same group shall be allowed to board the boat.
- iv. Alcohol and alcohol-based hand sanitizers must be present on board the boat at all times.
- v. The full passenger capacity as well as the 50% passenger capacity of the vessel must be displayed at all times to provide transparency and for easy reference.
- vi. Only one (1) guest per parasailing activity shall be allowed.
- vii. Passengers must wear complete safety gear such as life vest, appropriate footwear, and other safety protective equipment AT ALL TIMES during the parasailing activity.

- viii. Safety gear and other related parasailing equipment worn by guests during the activity shall, after each use, be sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- ix. Frequently touched surfaces of the vessel shall be regularly disinfected upon disembarkation and prior to embarkation.

#### **K. Hiking, Trekking, and Mountaineering**

- i. Operation shall be from 6:00 AM until 3:00 PM only.

Operation beyond the prescribed hours is only allowed upon approval of the *Cebu Provincial Tourism Task Force*.

- ii. Guests must be divided into groups before proceeding to the activity areas. Groups will be composed of a maximum of five (5) persons to be accompanied by one (1) trained guide.

The guide must wear a face mask and a personal air purifier at all times.

Guides must strictly observe good personal hygiene and wear proper uniform.

- iii. Only persons travelling together shall be allowed in a group.
- iv. Strict physical distancing shall be observed, with a seven-minute interval between each group.
- v. Visitors must wear complete safety protective equipment such as helmets, hiking shoes, and other safety protective equipment AT ALL TIMES during the outdoor activity. A list of the prescribed gear must form part of the Tourist Brief sent to guests prior to the activity.
- vi. When guiding, they must be equipped with a two-way communication device and safety and emergency equipment, such as, but not limited to helmet, rescue rope, and other similar gear in accordance with appropriate equipment standards
- vii. Touching of flora and fauna along the trail is strictly prohibited. Only established trails should be used.
- viii. Gear and equipment that are rented out should, at the end of each use, be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

- ix. Outdoor operators shall set aside one day of every week for cleanup and maintenance. The *Cebu Provincial Tourism Task Force* shall be notified of the appointed day for supervision and monitoring.

#### **L. Spelunking (Caving)**

- i. Operation shall be from 6:00 AM until 3:00 PM only.
- ii. Guests must be divided into groups before proceeding to the activity areas. Groups will be composed of a maximum of five (5) persons to be accompanied by at least one (1) trained guide.

Only persons travelling together shall be allowed in a group.

Guides must strictly observe good personal hygiene and wear proper uniform.

- iii. When guiding, guides must be equipped with a two-way communication device and safety and emergency equipment, such as, but not limited to helmet, rescue rope, life vest (if applicable) and other similar gear in accordance with appropriate equipment standards.

They shall also wear face masks and personal air purifiers at all times.

- iv. Strict physical distancing shall be observed, with a seven-minute interval between each group.
- v. Only 50% of the maximum carrying capacity per day shall be allowed in the area for spelunking activities.
- vi. Visitors must wear complete safety equipment, such as helmet, hiking shoes, and other protective equipment AT ALL TIMES during the spelunking activity. A list of the prescribed gear must form part of the Tourist Brief sent to guests prior to the activity.
- vii. Gear and equipment that are rented out for the spelunking activity should, at the end of each use, be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

- viii. Outdoor operators shall set aside one day of every week for clean-up and maintenance. The *Cebu Provincial Tourism Task Force* shall be notified of the appointed day for supervision and monitoring.

#### **M. Visiting Cultural Heritage Sites and Museums**

- i. Personnel of cultural heritage sites and museums shall wear face masks, face shields, and personal air purifiers at all times.
- ii. Temperature checks shall be administered to all guests upon entry. Those exhibiting influenza-like symptoms shall immediately be turned over to the City or Municipal Health Officer for proper management and handling.
- iii. Physical distancing markers should be placed in visible areas with at least one (1) meter distance between each other to guide queuing guests.
- iv. Foot baths must be placed at the entrance of the reception area.
- v. Acrylic or glass barriers may be set up at the front desks.
- vi. Alcohol and alcohol-based hand sanitizers as well as tissue or paper towels must be made available by the establishment at all times.
- vii. Frequently exposed areas of the site or museum must be properly sterilized with an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

**Section 4. Mandatory Minimum Requirements for Operation of Dine-in Services.** In addition to the guidelines prescribed by DOT Memorandum Circular Nos. 2020-002, 2020-004, and DTI Memorandum Circular No. 20-37, as amended by DTI Memorandum Circular No. 20-39, Series of 2020, the following measures shall be observed

- i. Open-air and well-ventilated dining is highly encouraged. However, for indoor air-conditioned dining, proprietors are required to install an air-purification system with HEPA filter and ionizer.  
  
The capacity of the air-purification system must be proportional to the area of the restaurant.
- ii. Dine-in shall be limited to 75% of the establishment's full carrying capacity.
- iii. Buffet service shall be allowed only when
  - a. Food servers are present in the buffet area; and
  - b. All food trays are with food covers.
- iv. Fruit and vegetable dishes, as well as freshly squeezed juices, such as, but not limited to, turmeric-infused, honey-sweetened calamansi juice, are highly encouraged.

- v. The kitchen and other food preparation areas as well as kitchen utensils and equipment shall be regularly sterilized with *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.
- vi. Regular disinfection and sterilization of the restroom with *Ultraviolet Germicidal Light* shall be observed.

**SECTION 5. Accommodation Establishments.** All accommodation establishments must secure a Certificate of Authority to Operate (CAO) from the Department of Tourism **AND** a Special Permit to Operate from the local government unit having jurisdiction over the establishment.

The CAO shall be a prerequisite to the issuance of a Special Permit to Operate.

The operation of accommodation establishments shall strictly observe the guidelines under DOT Memorandum Circular Nos. 2020-002, 2020-004, and DTI Memorandum Circular No. 20-37, as amended by DTI Memorandum Circular No. 20-39, Series of 2020.

Accommodation establishments shall thoroughly disinfect rooms and common areas using electrostatic sprayers with hospital grade-disinfectants at least once every two (2) weeks.

For air-conditioned rooms, the installation of air-purification systems with HEPA filters and ionizers is strongly encouraged. The capacity of the air purification system must be proportional to the area of the room.

The suites and the common areas shall be regularly sterilized after every room cleaning using an *Ultraviolet Germicidal Light*, with STRICT OBSERVANCE of the instructions on proper handling and use of the device.

No guest shall be allowed inside a room while routine daily cleaning is being done.

Only bed linen and towels that have been properly sterilized with *Ultraviolet Germicidal Light* shall be provided to guests.

**SECTION 6. Curfew.** Curfew within the Province of Cebu shall be from **12:00 MN to 5:00 AM** of the following day.

Restaurants shall be allowed to open until **11:00 PM**.

To this end, Section 2 (2.9) of Executive Order No. 20, Series of 2020, is hereby amended.

**SECTION 7. Health Regimen and Safety Measures.** All persons within the Province of Cebu are encouraged to boost their immune system to effectively combat COVID-19 by following the *Health*

*Regimen and Safety Measures* under Section 7 of Executive Order No. 20, Series of 2020.

Those establishments involved in the activities mentioned in Section 3 hereof shall, as far as practicable, integrate the aforementioned *Health Regimen and Safety Measures*.

**SECTION 8 Monitoring.** Members of the Tourist Police of the Philippine National Police, Philippine Coast Guard, and the Bantay Dagat shall be designated as the security and safety officers charged with overseeing all tourist-related activities and the enforcement of the prescribed safety and health protocols.

The *Cebu Provincial Tourism Task Force* shall ensure that all the protocols and guidelines under Section 3 hereof are followed.


**SECTION 9. Effectivity.** This Executive Order shall take effect immediately upon its issuance. However, the opening of specific activities shall be subject to the readiness of the establishment and the Local Government Unit having jurisdiction over the same as determined by the *Cebu Provincial Tourism Task Force*.

A certificate certifying the readiness of the establishment to open and launch the tourism activity shall be issued by the *Cebu Provincial Tourism Task Force*.
